Home Base is a multi-level program that provides support and services to run away, homeless, and transient youth and families in Calumet, Outagamie, and Winnebago Counties. Children are, by definition, one of the most vulnerable populations without a voice.

Valuing the Dignity and Worth of the person requires social workers to always be mindful that each person has their own set of values, their own story and experiences, and their own social and cultural norms and diversity. Respecting the dignity and worth of others creates an opportunity to resolve social conflict in ways that values each person within a larger context of understanding.

Social Workers recognize the critical role that positive Human Relationships play across micro, mezzo, and macro-levels of change. Because the dynamics in human relationships can be challenging at times, it is vital that social workers maintain high levels of communication and practice patience in their interactions.

Integrity is integral to the success of a social worker in facilitating positive relationships with others and among others. Social workers must be trustworthy to uphold strong ethics and boundaries. Social workers must honestly represent themselves at all times, while also maintain strong boundaries between the personal and professional self.

An exorbitant amount of a social worker's experience comes from real world exposure and practice. Because social issues and needs are always evolving, it is the responsibility of the social worker to remain continually committed to further education, expanding his or her knowledge base, and being cognizant of best practice and trending social issues. Equally important is that social workers maintain humility withing their scope of practice.
