Dear Appleton School Board Members,

A safe and effective COVID-19 vaccine has been available to the general public at various Fox Cities locations for roughly 5 months now. The overwhelming majority of healthcare and scientific communities, and the evidence published in numerous studies (for more information see the CDC website), deem this the best and safest way to combat a deadly virus that, in its dominant Delta variant, is easily spread between unvaccinated people in enclosed spaces such as school classrooms, far more easily than the strain of COVID-19 that spread in our community in 2020 and early 2021. This vaccine, however, is not available to all community members. The most vulnerable (immunocompromised people) and youngest (children under 12) do not have a save and effective vaccine to protect them and their immunocompromised family members from transmission of Delta variant COVID-19 in school classrooms.

Earlier this summer, the school board voted to disallow requiring masking in school settings. The US Center for Disease Control and the Wisconsin Department of Health, two of many evidence-based nonpartisan scientific public institutions, have stated that the unvaccinated should be wearing masks indoors and in crowds ("If you are unvaccinated, wear one in all indoor spaces that are not your home, as well as enclosed or crowded outdoor spaces"-- direct quotation from the Wisconsin Department of Health's main homepage). Since no children under 12 (which corresponds to nearly ALL students in AASD elementary schools) qualify for a safe and effective vaccine, they should be masking indoors in AASD elementary schools to protect their fellow unvaccinated students. Clearly many parents and children themselves are confused or misinformed about the effectiveness of this safety measure and the danger of continuing the spread of COVID-19 in our community.

Stopping the spread of COVID-19 in our community is critical to providing the best in-person education AASD can provide. Keeping students, teachers, and AASD staff safe and healthy, and free of transmissible COVID-19 virus is the most important way to provide this education by keeping our schools open and in-person. This can be accomplished by supporting mask requirements in all elementary schools.

As elected school board members, your responsibility is to stand up for these most important community members (our children) and help keep them safe. K-6 students returned to in-person schooling in winter 2021 and navigated school with a mask requirement in place in indoor school settings. They understand the importance of this safety measure and continuing this practice is not an infringement on the freedoms of young children, when they are unable to protect themselves in this setting. They are entitled to a quality public education and safety is part of this.

Please do not be swayed by misinformed vocal groups who go against evidence-based scientific recommendations from our public institutions. Vote to follow the recommendations of the US CDC and the Wisconsin Department of Health regarding masks in indoor settings for all (presently unvaccinated) children under 12 in AASD schools.
