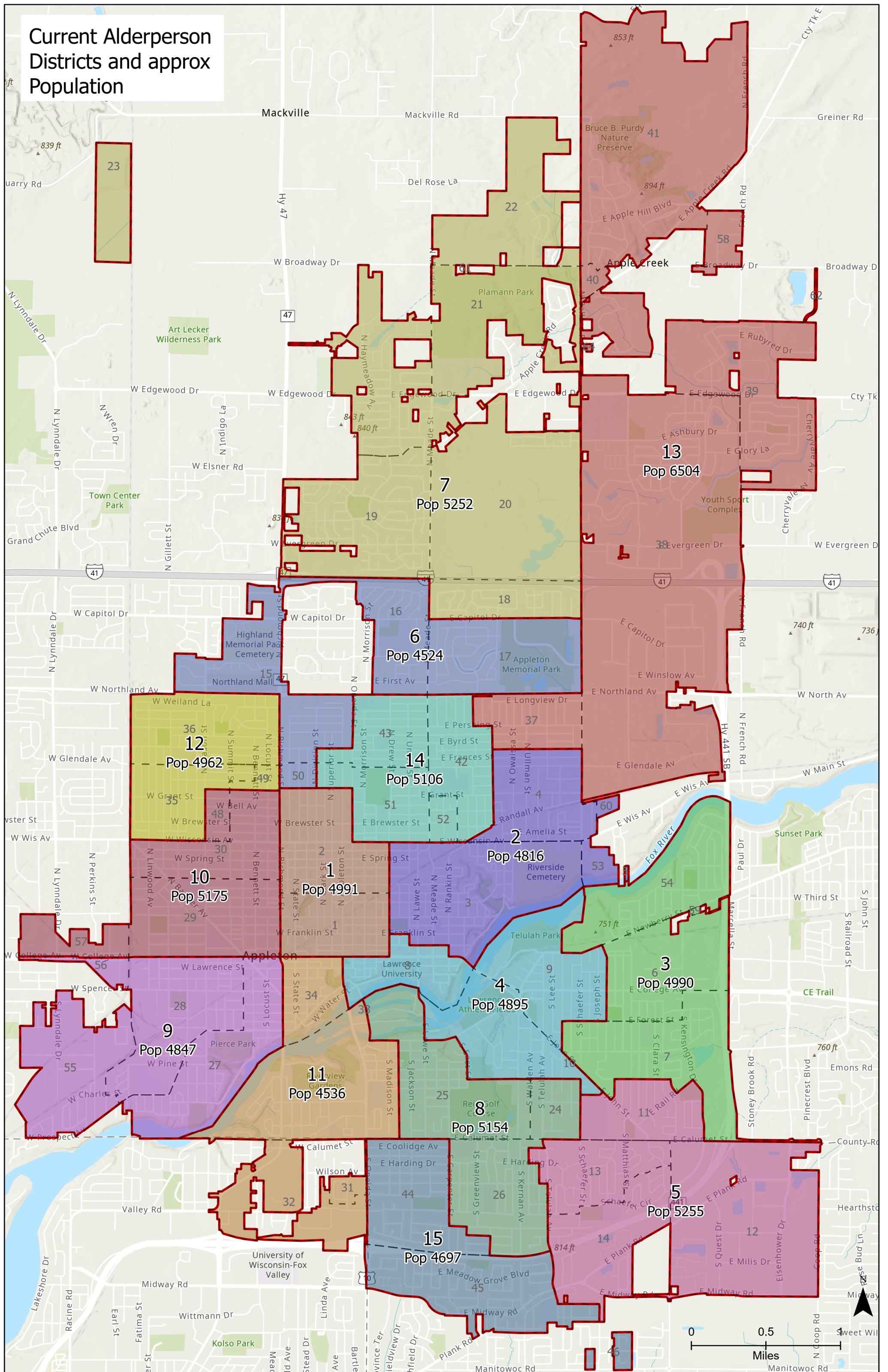

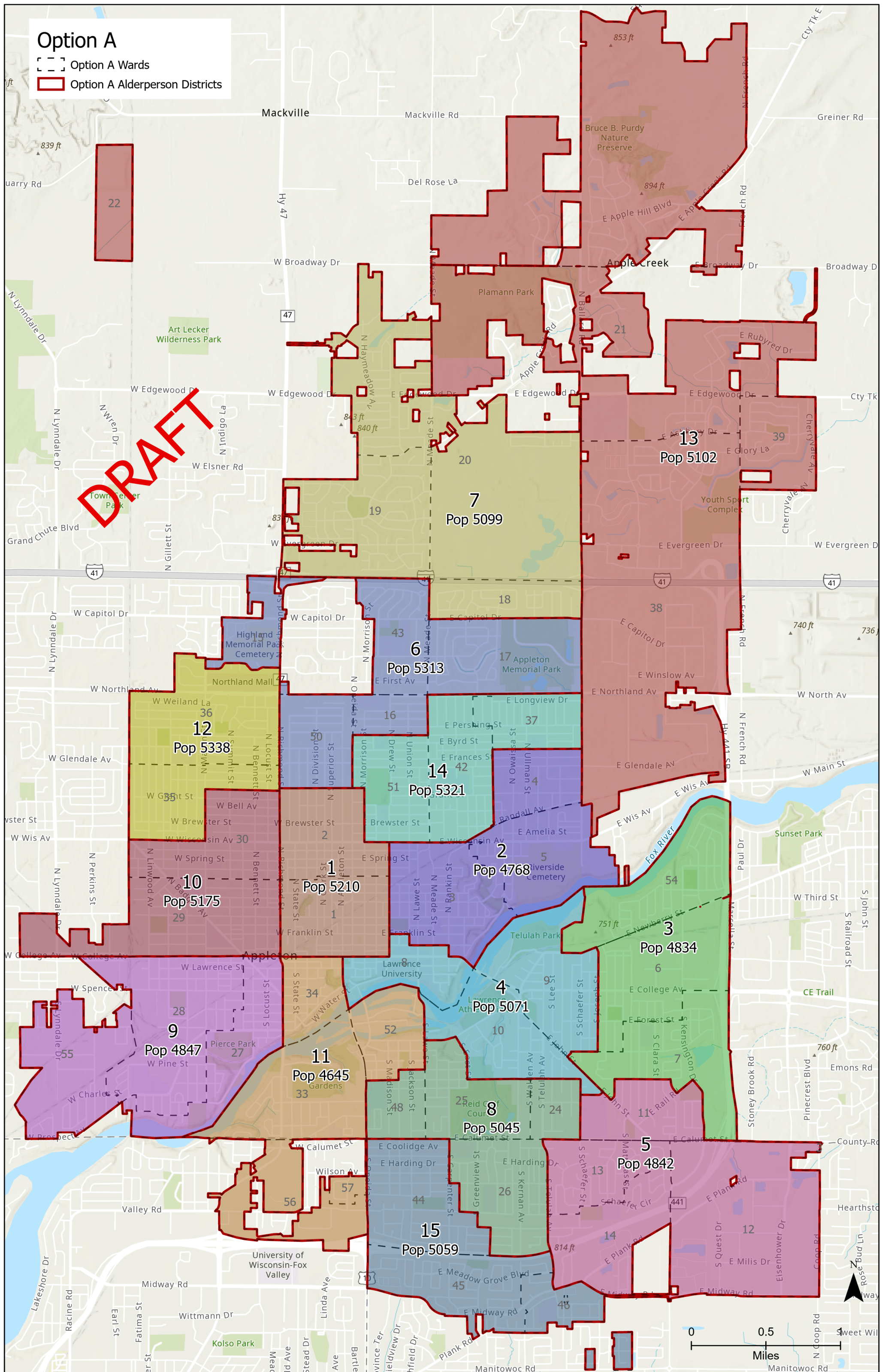
Current Alderperson Districts and approx Population

- Option A Alderperson Districts

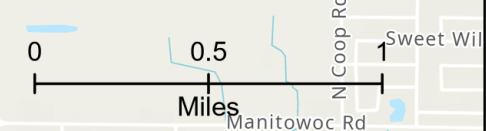
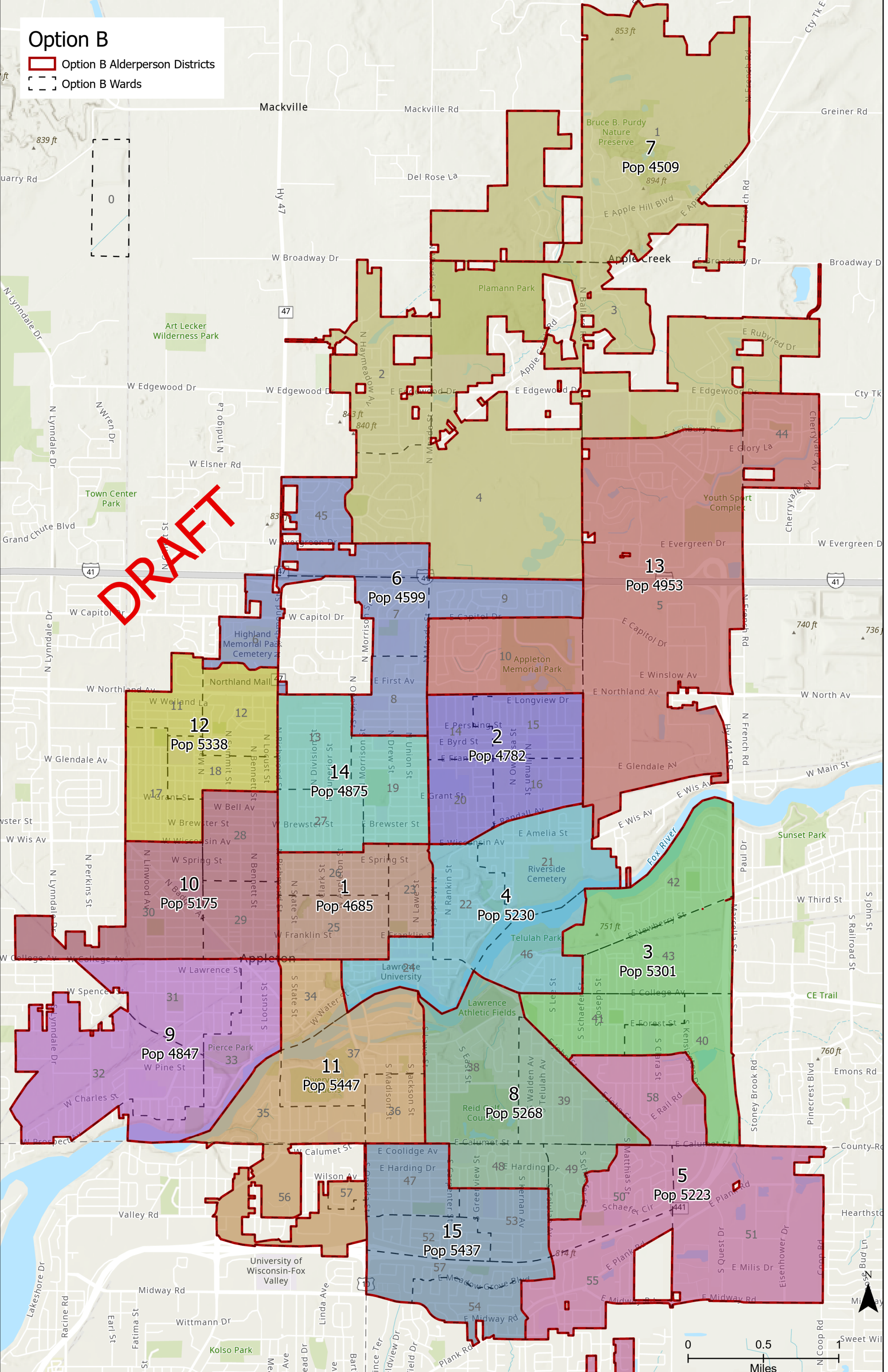
