Thank you Chair. Yeah, so we have a development agreement for 318 West College Avenue that was approved back in March or signed back in March of 2021. As is not uncommon in a redevelopment of properties downtown, they experienced some surprises, some delays. Primarily in this one it was the need for new foundation. And in putting that foundation in that meant cutting out the existing basement and actually hauling a lot of that out with buckets. So that took a lot longer than they had anticipated when they started this process, in addition to some of the supply chain issues that everyone's been having over the past year as well.

So in our development agreement, we have two critical deadlines in there. One is December 31 of 2022, the project is supposed to be completed. And the other deadline is to achieve a minimum assessed value of \$8.1 million by January 1 2023. The property owner anticipates completion in April of 2023. Obviously, if you walk down the street, you'll see he's been working in good faith to get this project done. But he just needs a little bit more time to kind of offset some of those delays we talked about.

So what we're asking for is a six month extension to the completion date. So instead of December 31, it would be June of 2023. And then also the assessed value since that is assessed--the assessments are calculated as of January 1, we're looking for a 12 month extension on that to January 1 of 2024.
