Do I think so? No, I don't. But there's obviously always the flip of a coin, if you're going to do it or not. Just with the cost of everything skyrocket in the last couple years, it's an it's a way for us to help try to offset some of those costs. So the benefits outweigh the negative.

And as a follow up if I may? It is there a way for us to couch this with people? Or are we just going to say, here are our rates? Is there a way to, you know, essentially advertise it as "We didn't want to do this. But we have to do this to recoup our costs." People generally understand it costs more for gas, it costs more for lawn maintenance, it costs more for all of those things. Are we going to present it that way? Or are we intending to just presented as "here are rates" and take questions as they come?

# Jeff Plasschaert (Golf Course Superintendent) 11:16

That's a—that's a great point. Typically, we—this is a little bit later than we've normally done this so we might be selling like 2023 annual passes already. Where this year by the time it gets approved here, hopefully, and then by Council we'll be done selling passes for the year. So we really won't be selling these until next year, where there's a little bit of a period there where they kind of forget about us. It's not that we're not trying to sell stuff. But no, that's certainly something we can do is marketed that way just to say that we're offsetting our costs.

# Director Dean Gazza (Parks, Recreation, and Facilities) 11:20

If I can add to that. So Jeff has a sheet here, where he looks at all the local golf courses, and then he'll, he'll go against what everybody else is. So we're still very competitive. So that's very important. So rather than just raising the rates without any information or background to it, so maintaining that. And then we didn't raise costs across the board in each category. They were very selectively chosen based on how low we were compared to our competitors and where we figured where the best areas of opportunity. But yeah, otherwise, you know, I think maybe a private entity might have taken the opportunity to use rising costs as an excuse to just raise everything in which we were very selective. So every year something gets raised, but it's always based on information we learned from the year before.

Oh, yes, we did do exactly as you said and did our homework to look at the surrounding communities and municipalities to see what they were charging. Some of the surrounding communities have newer facilities and they were charging more than we were for a smaller facility and less amenities. So we do feel—it's been a while since we've updated the admission fees and the passes. So we certainly feel

with inflation and just the increase to—like our seasonal staff wages that we're going to incur this year, which will be a fairly large hit for us and recreation because we hire over 200 seasonals a year. So that's just to recover that cost. And we definitely feel that we'll be competitive with the rates were proposing.

So if they don't have an increase, it would be cheaper to get a non-resident pass from a neighboring municipality for their pools.

So I can't speak exactly to which ones I know, one of our recreation programmers that oversees our aquatics portion of our programming, does know—I think there were a couple of them, I can't recall which ones, that we're going to be increasing. But we do also—keep in mind, and this might just be a reminder—we do have reciprocity with the City of Neenah and the city of Menasha. So our residents and their residents get reciprocity for passes and stuff. And we do have early bird rates for our past sales. So if they do it—I'd have to look at the deadline for the early bird but they get a discount on their passes. And I think that's in the back of the policy it shows the early bird versus the regular resident rate.

Thank you. Niki. Can you just bare bones this for me? What did we change? I mean, I looked at it all but give me a brief overview of what we're looking at.

# Recreation Manager Niki Wendt (Parks And Recreation) 19:58

Yes. So In the past, there were specific times listed in the policy for the rentals. And because our hours have changed over the years of when we do open swim and stuff, we just wanted to take the hours out and refer people to the website for the—so we didn't have to come back every year that we ended up changing the hours of the pool. Umm remove the West pool option as a rental, because we used to have that as a birthday party rental. So took that out. And we used to allow them to reserve the pools 12 month in advance, and that was because we had West pool. And now we're just requiring them that as of the first of the year of the existing year, they can rent the pool. So we're not dealing with people

doing it that far in advance. And then the refund guidelines we just made consistent with our recreation fees policy. So that was a minor change. And then just the rental fees were increased. We kind of cleaned up some of that. I know that this policy is really hard to read it with the red lines. So I apologize. There are a lot of scribbles going on here. But so yeah, we increased some rates. We made we simplified it a little bit. If you see on the lat—on the one page where we note the rental fees, we took out what's called the shade pavilion, and we used to have a birthday party package and a shade pavilion package. And no one ever just rented the shade pavilion without doing the admission. So we're like, let's just get rid of that. No one's doing that anyways. And yeah, remove West pool, like I said on their fees. And then the last page. We never had in the policy what we were charging the swim teams for practices. So we felt that was important to put in the policy.

And you had been charging the swim teams, it's just it wasn't in the policy written?

And then the same question. Not that it matters as much, because obviously we're looking at a smaller group of people that will take advantage of this particular policy, but do you see any of this as extremely prohibitive to those folks who take advantage of that?

I would say based on the demand we've seen over the last few years, no. And we don't, you know—we don't have a lot of times that we're able to rent the pools for private rentals, I would say. Open swim is when they're renting the shade pavilions in the shade arbor spaces for parties, but we only allow—it's like Saturdays and Sundays from 9:30 to 11:30 in the morning, and then 7:30 to 9:30 at night. So we're pretty limited to when—I mean those pools are

Yeah. And it's tough to we've had to eliminate how often we can allow rentals because it's a lot on our staff. You know, when you're already kind of bare bones for your staffing, it's hard for us to say, "you're gonna work starting at six in the morning for swim team practices, and you're gonna stay till 9:30 at night because we have a private rental." So we've tried to be conscious of staff burnout too. And so there's not a ton of time they can do private rentals, but mostly weekends in the mornings or in the evening.
