I do have one non budget item. It's our WPDES permit's going to be reissued January 1, '23. And we've been asking for compost to be included. I've kept the committee briefed on this. They have not come back and said we can have a compost facility at the facility. All right? So, we still have it out at the county. There isn't any reason why we can't continue to do that for the next couple of years. But it's unknown whether or not we'll be able to have a compost facility in the city of Appleton. So, I'm just bringing it out there.

I definitely want to keep an eye on what's going on with that compost situation because I think that, you know, we have a great legacy and we have a lot of investment in bringing biosolids composting to Wisconsin as a pioneer. Just a follow up, Director Shaw. Do you have a sense of why you haven't heard back on the biosolids composting? Is there is there any indication of what the—?

Chairperson Meltzer mentioned it. We're the, you know, a leader, and so it's difficult for the state to do anything this new. So, if you're the first—right?—every decision in their decision tree has to be run through, you know, risk assessment, you know—I mean, all kinds of things that they're just not normally used to doing. So. Just it is what it is.

And placing a compost facility in a metropolitan area, there is just some just general issues with like odor, what would it do? And we should have those same concerns too. We have the ability to do certain things, and some things we can't do. So, before we invest, we, you know, we've reduced it to the building. We're going to try—we were going to compost within the facility. But we have to be given the okay to be able to actually do it at all. Right? So, we don't have any authority to do it unless we have permission from the DNR at the facility. It would be considered a new outfall under the permit. And we can't take biosolids compost out of that facility. We can't create it and take it out of that facility. We can do it at the county. It's already approved out there. So, it's just.

Do you feel that maybe the issues that we're experiencing statewide with staffing and that kind of thing, is that maybe affecting their capacity for workload and affecting this at all? Or is it really just kind of more the different hoops they have to jump through because of the novelty?
