Starting with 23-0061 request to sole source contract to Parker Coatings for Fire Station One rig room floor epoxy in the amount of \$40,674, with a contingency of \$4,068 for a project total not to exceed \$44,742.

#### Director Dean Gazza (Parks, Recreation, and Facilities) 01:06

Thank you, chair. At the last meeting that was held. And it was requested that there was information that would be brought forward by our purchasing manager justifying the sole source or support of the sole source. So, there is a form that was included in the packet, chooses a basically a form talking about it. And in the notes section below, it will talk about a mechanic floor was—it borders another floor that was completed previously by the same company. So, for the continuity of it, and then you know, warranty and everything else. And then the fact that we talked about last time, just the quality of the installer, and then the overall value because of the product they're using also is a high-quality product.

All right. Any questions from committee? 15, yeah. All right. Alder Hartzheim.

#### Alderperson Sheri Hartzheim (District 13) 02:08

Thank you. My question is, do we have any idea whether this is anywhere within the bounds of any open bidding that we would have received? Obviously, it's probably a higher scale, but is this—you know, is this 50% more than what we would have paid for a different supplier?

#### Director Dean Gazza (Parks, Recreation, and Facilities) 02:29

No, I don't know the exact number. But it wasn't that much higher. The numbers were higher but not substantially higher, not like double or anything like that. I don't wanna say specifically, because I know if I say 12%—I don't know the exact percentage.

#### Alderperson Sheri Hartzheim (District 13) 02:48

So, we expect to pay more. But we're paying for higher quality. But we're not. We're not so far out of bounds in this that we're way overpaying because we're sole sourcing?

# Director Dean Gazza (Parks, Recreation, and Facilities) 02:59

No. The other thing is when the other floor was done, they were they were the low quote. And so, it was done with that product. And so, the continuity of keeping it in the same building, and it borders it, is our goal here.

Just one quick add-on to that, if I may Director Gazza. That last—the other floor was an open bidding process. Correct? So even though this is a sole source request, that one was open. So...?

#### Director Dean Gazza (Parks, Recreation, and Facilities) 03:27

From what I can recall, yes.

#### Director Dean Gazza (Parks, Recreation, and Facilities) 03:28

Yeah, we don't request the sole source very often. But in a situation like this, the facility manager, you know, and I definitely supported it, because the harsh conditions in the fire stations that they have, and then from a warranty standpoint, when they come back, if they scratch something, we're fortunate to get it patched too.

All right thank you. I just wanted to establish that this hasn't been just a—this facility hasn't been just a single source, that this has been competitively—this company did win this business before. So, there's at least some merit to whether or not they would perform well in a bidding process.

And I should add to say, say we're getting pricing to put epoxy flooring in another location. It wouldn't necessarily—this one was more important to the facilities manager just because of the floor that was already there. But we could end up working with every company in Appleton eventually.

Because I think if we waited anymore longer on a contract, then we'd end up rebidding at some point.

So, I am hopeful as well, that Thursday's meeting, again, with the neighbors will kind of calm everyone's fears and we can move forward with this but in a different way than what's initially here.
