Re:	Request to upgrade Facilities truck #503 to a crew cab pickup truck with four-wheel drive when it's replaced in 2024

CEA fleet vehicle #503 is a 2012 Chevrolet Colorado extended cab, rear wheel drive pick-up truck with 27,700 miles. Vehicle #503 is assigned to the Facilities Management Division and is primarily used by the Facilities Manager and Assistant Facilities Manager for visiting City facilities, parks, and transporting facility equipment and supplies. In addition, facilities maintenance staff utilize vehicle #503 for transporting supplies and equipment as #503 is the only full bed pick-up truck in the Facilities Management Division vehicle fleet.

The Facilities Management Division is requesting to upgrade vehicle #503 to a crew cab pick-up truck with four wheel drive. Existing vehicle #503 is an extended cab which does not have sufficient space for storing and transporting equipment, supplies, or staff. A crew cab will provide space for storing and transporting equipment, supplies and staff. Existing vehicle #503 is rear wheel drive making winter travel challenging, unsafe and not feasible. The proposed upgrades to vehicle #503 will better serve the Facilities Management Division for winter transportation and transportation of supplies, equipment, and staff. Existing vehicle #503 will be moved into CEA's aging Second Life Fleet.

The estimated cost for the upgrades is \$5000.00 If approved, the additional cost for the upgrade will be included in the Parks, Recreation and Facilities Management budget request for 2024.

Request to keep Dodge Durango #803 until the replacement for van #807 arrives in 2024. Re:

The Appleton Fire Department (AFD) added a new Battalion Chief of Emergency Medical Services (EMS) to the table of organization through the FY2023 budgeting process. This new 40-hour per week position will need a city vehicle to transport medical equipment and attend committee and department related meetings and trainings.

As approved by the CEA Review Committee in 2021, CEA ordered a new Ford F-150 pickup truck to replace the Fire Chief's Dodge Durango #803. This was ordered in November of 2021 as part of the 2022 CEA equipment replacement program. Due to supply chain issues, we expect this truck to be in-service sometime in early 2023. As part of this process, CEA planned to place Durango #803 back into the second use/reserve fleet once the new Ford F-150 arrived for the Fire Department.

Additionally, the AFD has a 2015 Chrysler Mini-Van #807 that is due to be replaced in 2024. CEA was informed that this van model currently is not available for purchase under the state contract, or available to Fleet Sales. Therefore, CEA and AFD researched the closest replacement option available. This looks to be the Ford Explorer which will be at or below the price point of the Chrysler van.

Because the current setup in unit 807 does not meet the needs of the new Battalion Chief position, the Fire Department, with the support of CEA, are proposing the following solution:

- The new Ford F-150 be assigned to the Battalion Chief of EMS as their primary use vehicle. •
- The Fire Chief continues to use the #803 Dodge Durango for the next 12-18 months.
- CEA orders a Ford Explorer to replace #807 Chrysler Mini-Van. .
- Once delivered, the Ford Explorer is assigned to the Fire Chief. •
- Both #803 and #807 go back to the CEA fleet for reassignment.

Subject: Request to add Second Use Sedan to Health Department Fleet in 2023

This request is for a new public health nursing vehicle through CEA's second use vehicle fleet, as was funded through the 2023 general funds budget. The need for a nursing fleet vehicle has arisen due to recent changes to City travel reimbursement policy. These policy changes led to a stipend model based on FTE, vs. a reimbursement model. Most Public Health Nursing staff are part-time, and the reimbursement per FTE is disproportional to the amount of actual costs incurred by staff travelling within the City to perform their assigned duties.


An exponential growth in TB cases and associated directly observed therapy (DOT) has dramatically increased the need for Public Health Nursing staff to travel. A fleet vehicle for Public Health Nursing staff is required to avoid the current scenario where staff are subsidizing the travel needs of the department. The addition of this vehicle to the Health Department fleet will ensure delivery of these vital services without being subsidized by City staff.

This request will not have an impact on the current Health Department budget, as estimated amounts for this vehicle were included in the 2023 Health Department budget, which was approved by the Appleton Common Council. The estimated CEA costs are similar to pre-policy-change budgeted mileage reimbursement. The 2023 budget lines for this vehicle additions are listed below. These budgets will be adjusted as needed from year to year.

CEA Operations/Maintenance: \$1770 CEA Depreciation/Replacement: \$775

Re: Request to keep tractor #593 as a spare in the Stormwater fleet

Parks, Recreation & Facilities Management Department is requesting permission to keep Tractor 593 as a spare and move it into the Stormwater fleet after it's replaced in 2024.

Tractor 593 is a large agricultural tractor that was originally purchased for weed mowing the right of way. The Expansion of Appleton has greatly reduced right of way areas that require weed mowing. Tractor 593 is used currently more by Stormwater to mow around ponds and along ditches. Tractor 593 is a 2012 model with only 610 hours. Placing 593 in the Stormwater fleet as a spare provides Stormwater with a low hour tractor for their cutting, while leaving it available to PRFMD for the few right of way sites that still require mowing.

The monthly CEA charge for unit 593 is \$68.00 per month, plus fuel and maintenance costs.
