Pretty—this is a pretty standard request. CEA met with the department, the customer in this case, parks and facilities. And they decided that this—their needs would be better served by upgrading this pickup truck. And that's what you see in front of you. So, like, typically, we do in this case, the amount for the standard replacement would be covered by CEA but the amount for that's over and above that, like kind replacement (in this case about \$5,000) would be covered by the Facilities and Parks 2024 budget.

No. For the additional expenses that the facilities management budget would absorb that additional expense.

Yeah, basically we can't get the minivans that we once used for our fleet. So, we're just holding on to that Durango until the end of this year and we can get which now looks like we'll be a Ford Explorer in, and then the chief is going to end up driving that Ford Explorer So we're just kind of holding on to that vehicle versus trading it in right now until we can get something to replace it.

I'll just add. It's been more and more common over the last couple of years where the auto manufacturers are scaling back what models they're going to produce. And we find out, like we did here, that what we'd like to order is not an option anymore. So, then we work on what's the closest fit to that. And that's what we came up with here in this case. And CEA is also supportive of keeping the additional unit until the time comes where they have their new vehicles.

The unit is. Oh, I'm sorry. The unit is—I'm Greg Hoekstra and the grounds manager for the city. The unit has already been purchased. They're waiting for it to be delivered. And then the question would be that they want to put it into the CEA—golf wants to put it into the CEA fleet.

Okay, any other questions, comments?

#### Deputy Director of Operations Nathan Loper (Public Works) 06:41

Nope, other than CEA is supportive of this as well. It's over the threshold, and it'll help golf down the road to have the funds available to replace it in like kind when that time comes.

Director Sepers would you like to speak to us on that?

#### **Health Officer Charles Sepers** 07:31

Yeah, I can speak—I can speak to that item. So basically, we are asking to add a second used vehicle to nursing. Currently we had a \$3,000 line item for staff mileage reimbursement, and with a recent policy change, moving to a stipend model rather than covering actual costs. It actually prevents us from, one, actually expending that line item and then also, two, covering the staff's costs for mileage needs.

#### **Health Officer Charles Sepers** 08:10

So, moving to a staff vehicle would both reduce that item. That line-item cost ends up being about 15—about \$2,500 versus the \$3000 that's budgeted for mileage. And then would also fully cover the expenses then for the staff time as well.

Just as a clarification, this is one vehicle so—

## Health Officer Charles Sepers 09:04

Yeah, we're a little out of cycle. So, I apologize for the confusion. This isn't that—the mileage piece is actually what the intended cost source would be for this vehicle. And this is after the 2023 budget has actually begun. So okay, out of sequence. So, it's a little confusing.

Apologies to all for misunderstanding that and thank you for the clarification. Any other questions, comments? All right. We have a motion in a second. So, hearing no comments or questions, we'll go ahead and vote. All those in favor please signify by saying aye. Aye. That passes three zero.

So, kind of a unique set of circumstances here. Our stormwater division over the years has really evolved. It started with no equipment. So, we've had to beg, borrow and steal a lot of times from Parks staff and other areas. We've come a long way. We're doing much better now as far as having that the equipment we need. This is one piece that is super valuable to stormwater. So, when CEA met with the parks staff to talk about replacing this this tractor, which they're going to do, it'll be slightly different than the way it's—than the tractor that they have now, currently. It'll better meet their needs. But most importantly, what we're asking for here is to keep the old one as opposed to selling it. That we'd keep it in the stormwater fleet, be available for stormwater folks

to use for the projects that they need it for, but yet still available for park staff then to borrow from us for a change if and when they need it.

No, nothing to add.

We have the man of many duties.

#### Deputy Director of Operations Nathan Loper (Public Works) 11:59

Yes. So, this is our standard request that we bring through every year, this time of the year. We—CEA works to find vehicles that have a little life in them yet and works with all the other city departments to find out who needs what for summer months or for special events and that kind of thing. So, this is a pretty standard list. I think the number of vehicles is probably pretty close, if not identical, to what we've brought through in the past. But we just like to make sure that everybody knows what's going on here with some of these seasonal second use vehicles.

# Alderperson Denise Fenton (District 6) 12:38

And we did get a motion, right?

#### Director Danielle Block (Department Of Public Works) 12:41

#### Alderperson Denise Fenton (District 6) 12:41

Okay. Any other comments or questions? Alder Hartzheim? If I can find it. There we go.

# Alderperson Sheri Hartzheim (District 13) 12:52

Thank you, Chair. My curiosity is just on the last item. What is seasonal about the mayor's office need for a general transportation vehicle? I don't think he does more in the summer than in the winter.

# Deputy Director of Operations Nathan Loper (Public Works) 13:11

Yeah, so I'm just reading this. So, unfortunately, the fleet manager—I told him "I got it; I should be able to cover." It's the question I didn't ask him. I'm thinking because there aren't any months listed here, it's more of a kind of like what we have at City Hall for our fifth floor; they share a car as needed. So, I have a feeling this is similar to that in that it's parked here in the ramp and between the mayor's office, attorney's office, they have a car available if and when they need one.

## Alderperson Sheri Hartzheim (District 13) 13:41

So, it doesn't necessarily follow like the rest of them follow a seasonal which is very understandable for summer use, that sort of thing.

#### **Deputy Director of Operations Nathan Loper (Public Works)** 13:49

Yeah, there's a couple on here like traffic, for instance. It's mostly in the summer. But they do use that weekends in the fall for special events, setting up signs for Oktoberfest, things of that nature. So instead of trying to identify months—if we put the months on here, it really be 12 months a year, but they might only use it eight times in the year. This is probably similar for the mayor's office.

## Alderperson Sheri Hartzheim (District 13) 14:13

That makes sense. Thank you very much.

#### Alderperson Denise Fenton (District 6) 14:17

Any other questions, comments? Okay, hearing none, we'll go ahead and vote. All those in favor please signify by saying aye. Okay, aye. And that passes three nothing.

## Alderperson Denise Fenton (District 6) 14:32

So, in the information items we have the first is 23-0270 the 2023 equipment purchase log. Any particular comments to make there.

# Deputy Director of Operations Nathan Loper (Public Works) 14:44

I'll just point out that probably not a surprise to anybody, the theme over the last couple of years and is holding true this year, prices are higher. Their higher than what we anticipate most times, and it takes longer to get the equipment after we order it. So just some big challenges that CEA has been facing. In 2022, we had a similar start to the year, but we ended up coming in just under budget overall, for the equipment purchases. Hoping that we can stay the same this time next year for 2023. But inflation is—it's tough.

## **Deputy Director of Operations Nathan Loper (Public Works)** 15:15

And the other challenge here as we haven't received a lot of the 2022 vehicles yet, so we really don't know what the actual cost from 2022 would have been for a vehicle. But yet, we're trying to predict what to pay in 2023. And really, the last number we can go off of is what we paid in 2021.

#### Deputy Director of Operations Nathan Loper (Public Works) 15:33

To compound that here in a few months, we're gonna be putting the budget together for 2024. And we're still going back a couple of years. So, credit to the CEA manager for coming in at budget—slightly under budget, but not being—you know for being conservative, but yet coming in, or having enough money available to make all these purchases.

# Alderperson Denise Fenton (District 6) 15:59

With that being said, what would you what would you gauge your confidence level at being at being able to get the equipment that's required this year for the budget that we have?

# **Deputy Director of Operations Nathan Loper (Public Works)** 16:16

Yeah, it's not looking great. So, we're still trying to get the 2022 equipment in, kind of like the fire example earlier. We ordered it in 2021; we're hoping it shows up here in 2023. It should. But it's—everything's about two years out.

# **Deputy Director of Operations Nathan Loper (Public Works)** 16:30

So, we ordered pretty much all the equipment right after budget adoption last November. And it's looking like some of the units will be here yet this year, but the carryover list will probably be pretty long again for the equipment going into next year.

#### Alderperson Denise Fenton (District 6) 16:46

Thank you.

## **Deputy Director of Operations Nathan Loper (Public Works)** 16:47

You know we're being told by even Ford, for instance, we ordered six pickup trucks last year and kind of at the 11th hour, we were told, "Well, we can give you one." So, it's just strange things happening, and we're doing the best we can with all that.

#### Alderperson Denise Fenton (District 6) 17:04

Thank you. I mean, obviously, we hear that in every committee. So, we appreciate what you're going through.

## Alderperson Denise Fenton (District 6) 17:11

So, moving on to our other information item 23-0271 the proposed 2024 equipment replacements. Any notes to give us there other than what we've already talked about?

# **Deputy Director of Operations Nathan Loper (Public Works)** 17:23

Yeah, just might be a good segue for where I left off. So, we're still holding 24 units, which is something we always like to celebrate equipment lasting longer than anticipated. So, you know, just like at home, if you pay off your car, and you get to drive it for a few more years. That's that that's a win.

## Deputy Director of Operations Nathan Loper (Public Works) 17:41

Now, we've, we've learned a few things here over the last few years with these delays on delivery, and we're factoring some of that in. So, in the past where we may have said, "Yeah, we could probably hold this pickup truck for another year. And let's, let's put it on replacement for 2025 instead of 2024." Well, now when we're having those conversations, we're asking the customer and their team, "Can you go two years, three years without this unit?" Because even if we order it late in 23 it may not show up until 25 anyways. So, we're holding fewer vehicles than we have in the past. But like I said, we're still proud of the fact that we still are able to hold two dozen of them going into next year.
