Dear Alcohol License Holder,

The purpose of this letter is to inform you of the status of the demerit points against your alcohol license for the premises known as OB's Brau Haus, located at 523 W College Avenue, in the City of Appleton. Furthermore, you are hereby required to attend the Safety and Licensing Committee on May 10th at 5:30 pm in the Council Chambers, to inform the Committee about your efforts to rectify the issues that caused the imposition of any demerit points.

Your establishment recently had a violation for having Nude/Semi-Nude Entertainers on the premises on December 16, 2022, which resulted in convictions on April 12, 2023. This violation carries an assessment of 150 demerit points. At this time, the license for this establishment has a total of 150 demerit points assessed against it within the last 24 months.

Please be advised that if any establishment holding an alcohol license accumulates 150-199 demerit points within a 24-month period, the license is subject to suspension for not less than 10 days nor more than 90 days. If any alcohol licensee accumulates 200 or more demerit points within a 36-month period, the license is subject to revocation. A copy of the ordinance was provided to you at the time you received your license.
