Thank you Chair. I'm aware that this particular property came to the Zoning Board of zoning appeals—don't say that wrong. And I'm interested in how this all—this piece also came to this committee.

Director Block?

Director Danielle Block (Department Of Public Works) 07:54

Thank you. So it came in at the same time through inspections. So this was a team effort between Community Development and Public Works with the request for the additional one foot on the fence that was along private property. That was on private property past the right of way line so that was a board of zoning appeals requests. Anything from the right of way into the into the road, in the public right of way, falls to municipal services committee, and it fell under the new street terrace policy that that we had updated, let's see, November of 2022.

Director Danielle Block (Department Of Public Works) 08:32

So this item was—it's all one fence, but when you enter the right of way, it drops down to three feet right before then. So it's a three-foot fence that encroaches into the right of way, and she desires to keep it where it's placed. So the avenue for that is the terrace occupancy permit and approval by the committee and payment of the annual terrace permit fee.

Director Block, in the additional requirements portion of page two of three that was attached to the agenda. There's a notation that says certificate of insurance or waiver. Can you explain that further as well?

Director Danielle Block (Department Of Public Works) 09:17

Sure. So in lieu of providing the certificate of insurance, they could also sign a waiver accepting and disclosing that they do have insurance to cover the any liability of that fence within the right of way. So she has signed that waiver and we have that on file in our office.

Alderperson Sheri Hartzheim (District 13) 09:34

Okay. And then as a final question, I think, is there any concern from your inspections division that this is a block to any kind of traffic, any kind of pedestrians, etc. that would be harmed by this remaining fence that this—that this piece is still in that right of way?

Director Danielle Block (Department Of Public Works) 09:57

That is one of the items we looked at, and staff did not have concerns from inspections or from public works in terms of entering the public right away.

Okay. So how did it come about that that was brought before the staff's attention? Was that? Is that on—do we do those on a complaint basis, then?

Correct. The entire fence, I believe, had a complaint.

Was the complaint regarding if it was in the public right away, or in another private space?

Director Danielle Block (Department Of Public Works) 11:08

I believe the complaint came in as just a general complaint about the fence in its entirety. So when staff began looking at it, we reviewed it from each angle, and the private side, and then if it was in compliance from the public side, and it was not.

Okay. I guess my concern was if it was the neighborhood saying this is unsafe, that wasn't something that you heard?

Director Danielle Block (Department Of Public Works) 11:34
