All right. Moving on to 23-0674, Dr. Sepers, prohibitive animal declaration.

Health Officer Charles Sepers 24:54

Yeah, and the only reason why this this is in here again—this is a, this is a declared dangerous animal known as Ghost. What had happened was the animal was—instead of compliance, the animal was sold and/or given to somebody else, was renamed Sasha to sort of fly under the radar. That was discovered. My understanding per Officer Fillebrown, the animal has been taken by a local shelter and so the that that process is already—has already, has happened, has has undertaken.

Okay. And thank you. And I'm sorry, I skipped—or anything else?

Lee Vogel (Board Member) 25:48

I just have a question about that. Does the shelter have the opportunity to give that animal to another family?

Health Officer Charles Sepers 25:57

No. So a prohibited animal designation requires that the animal not remain in the city of Appleton. What the shelt—my understanding is the animal was, was scheduled to be euthanized as a as a part of that process.

And is there a penalty for these owners to have, you know, circumvented or tried to circumvent?

I can't speak to what is beyond what is what is here. I don't know what citations were—may have been issued in this case.

I'm trying to remember did this animal come before us?

Health Officer Charles Sepers 26:35

Yes, it did.

Yeah, I'm thinking I'm remembering that. Yeah. Okay.

So I think what would be helpful is at a future board of health meeting will ask our Humane Officer Matt Fillebrown to join us, whether we have anything before us or not, at a future meeting, just to talk through the process, because we've had a number of questions today and at our last meeting, just about the process and how this gets monitored, how animals get tracked and across jurisdictions. So, I think it'd be really helpful to have Officer Fillebrown with us. So, Health Officer Sepers and I will work on getting that set up for a future
