Alright, looks like we have three public hearings today and some associated action items with those. So first public hearing 23-0733 rezoning 4-23for subject site located at 2600 South Heritage Woods drive. And for that we go to Don. What number are you? Number four.

All right, we're all good. Okay. ThedaCare is proposing to expand their existing community based residential facility, which is a CBRF. Currently, they have 20 beds. They're looking for immediate expansion of eight with the ability to increase that to additional 23 in the future. So, there would be a total of 51 beds at the Heritage facility is what is being proposed.

Principal Planner Don Harp 01:55

When staff was looking at the history files on this property, we noted that in the plan development that currently is the overlay on this property—It's G-98, it's a PDR3 G-98. We noted that the implementation plan document was not finalized or recorded. That document is required to be recorded to facilitate the implementation of the development standards which sets the zoning regulations for this property. With that not being recorded, there are no development standards. Therefore, no development can occur until there's some sort of zoning action proposed by the owner. Staff met with the ThedaCare team and provided them with some recommendations on how to resolve this issue. And they elected to initiate the rezoning of the property from the Plan Development Overlay District G-98 to the base R-3 multifamily district. That would allow them to apply for a special use permit to expand and conform the CBRF facility. And the other primary uses on the property would be categorized as a principal uses. So, the R-3 zoning district would allow them to continue the use and also expand the su—the CBRF. Staff has reviewed the findings for map amendments and are recommending approval of the rezoning request.
