Thank you, Your Honor. There were several related items in the, going to the heat—the generating project here. But I wanted to focus on this one. Overall, I wanted to extend my gratitude for the hard work of the facilities department and sustainability manager Schrage for achieve—for obtaining the grants of over half a million dollars for this project.

And this project is going to generate 504,000 kilowatt hours. A question I asked it finance committee which our staff very quickly got back to me with the answer on, that will power 46.8 average Wisconsin homes for a year. Also that alternative heat project is going—our biogas generation is going to go from 12.4 tons of CO2 to 0.8. In addition to what we as a city are reducing in terms of greenhouse gases, We are—WE Energies (and we've probably all heard that we energies is going to come to all of us for a rate increase this year), WE Energies is going to reduce their CO2 emissions by 214 tons, just based on the reduction in power that the city of Appleton is going to have to, you know—that what we're going to generate.
