ITEM OF INFORMATION

Topic: Health Care and Plan Design

Background

Information: The Appleton Area School District is committed to providing our employees access to quality health care. Over the past several years, health insurance and health care costs have greatly increased, impacting both our employee's finances and the district's budget. In an effort to mitigate these costs, in January of 2023, AASD transitioned to self-funding health care. In addition, a primary care-based health care model was incorporated into the employee clinic and incentives (waived co-pays) were provided to encourage staff to access high quality, low cost care. These efforts were to mitigate costs long-term while providing quality health care at an affordable cost.

Since transitioning to self-funding health care, the district has avoided significant health care cost increases. For 2023, the most competitive bid for a fully insured plan with comparable benefits was a 23% increase and for 2024 the projected increase is 28%. These increases would have cost the District approximately an additional \$16 million dollars over a two-year period above the self-funding costs.

The renewal rate will increase by 10% effective January 1, 2024 for the current plan and third party administrator (Prairie States) with a projected increase of \$2.8 million over 2023. The rate is based on the market trend, employee utilization, and the District's claims experience.

Currently, the administration is exploring an alternative to the Personal Health Assessment (PHA) required by employees and spouses on the plan to receive a discounted employee premium. Also, the Health Reimbursement Account (HRA) was initially offered to offset a high deductible expense for employees and the current plan does not have a deductible. Furthermore, staff engagement in high quality, lower cost options is imperative to mitigating future rising health care costs. Therefore, the Health Reimbursement Account (HRA) will remain the same for 2024 with future consideration of discontinuing or reallocating HRA funds for 2025.

Instructional

Background

Information:

The discussion for these additional courses began last winter when the Senior Communication course was not approved by the NCAA Clearinghouse and Fox Valley Technical College communicated we would need to run the course as a semester instead of a full year. Additionally, AASD cannot offer Senior Communications for dual credit to all students, as not all of the teachers of the course have the credentials to do so.

We are currently offering Senior Communications for dual credit and advanced standing. The proposed Written Communications course would be similar in topics and application to Senior Communications but differ in rigor. In the future, Written Communication, running as a semester course, will not allow time for a literature component. With the proposed Written Communications course being offered in the future as a semester course, students will have the opportunity to choose from any of the current ELA elective courses (now to include Creative Writing 3 for students that have expressed an interest/passion.)

In addition, we are proposing an alternative full-year course, English Language Arts 12. This course will include many elements of the proposed Written Communication course while incorporating literature components and other real-life application skills.

Instructional

Impact:

Students will have further choice in their course selections for meeting their fourth required ELA credit for graduation. These options assist students in their varying needs regardless of their post-graduation plans. All three courses instruct and assess students using the Wisconsin State Standards for writing, reading, speaking, listening, and Conventions of Standardized English; however, Written Communication will not incorporate Standards-based grade reporting due to it being a dual-credit course.




