The next item is 23-1405 resolution 12-R-23 the closure of the Whitman yard waste site. I think during the 2024 budget process as the question on duplication of services or services provided occurred as we discussed the sanitation fund, staff had worked to pull a lot of that information together. So, if this were—I know there's a break due to holidays, or there's like gaps in the in the committee timeframe, but 30 days or the next committee meeting following 30 days, we could provide that initial stack of information to be considered. If there's additional, I guess, topics that committee members are interested in for us to bring back, if we would know that now, we could add that to the memo as well.

So, I think we have to kind of play that into the story of what will the customer experience be?
