I had three bartenders that were just cleaning the pub, and a few of my friends that were literally staying with me upstairs. I wasn't aware that no one can be in the building. The building was locked up, all the lights were off, but it was my mistake. I learned a lesson, and I apologize.

Well, I appreciate that. And you know, mistakes happen, and certainly when you own a business, you know, you become aware of certain rules that you may not know until something occurs. So, we can appreciate that. Is there anything that APD would like to add? Any—or Council? Sorry...okay go ahead.

If I can just share, I handled the citation. There was another citation that was dismissed for something similar, not the same thing, as part of the resolution of this matter. But the information we've heard here today is pretty consistent with the facts as I understand them. I'm not aware of any additional issues since the points were assessed, and if this really was the mistake that [Mr. M.] says it is, I expect that to continue. So, I think that's all I would have to add beyond what's already contained within the record.

Okay. And [Mr. M.], you understand this is a 50-point demerit you are assessed. Obviously took some time to go through the process and tried to—had it adjudicated and were assessed those points. So, this is one of those one offs where you learn from a mistake and you'll keep doing good business as you've done in the past.
