RE: Request for Noise Variance Unit O-24 Sanitary & Storm Sewer CIPP Liner

Dear Mr. Sepers:

This letter is to request a noise variance for an upcoming Department of Public Works project in the City of Appleton. The project will consist of installing a cured-in-place pipe (CIPP), in the sanitary and storm sewer system, and take place on the following streets and/or easements:

- 1. Esmnt e/o Weimar Ct. Weimar Ct. to 257' e/o Weimar Ct.
- 2. Esmnt e/o Vine St. Pacific St. to Peabody Park
- 3. Roemer Rd. n/o Northland Av. to s/o Northland Av.
- 4. Rankin St. 129' n/o John St. to John St.
- 5. Esmnt s/o Prospect Ave. Prospect Ave. to the Fox River
- 6. Opechee St. 50' se/o Pacific St. to Peabody St.
- 7. Jackson St. Hoover Park to s/s Roeland Av.
- 8. Esmnt n/o Garden Ct Garden Ct. to 236' n/o Garden Ct
- 9. Esmnt s/o Oakcrest Oakcrest Ct. to Lutz Park

This project will open bids on April 1, 2024. The contractor will be given a duration through December of 2024 to complete the project.

Depending on the size and length of the pipe, the CIPP process can impact the sewer service to a business or resident from 8 to 24 hours for this project. The residents may hear sounds, intermittent throughout the project, related to heavy equipment such as a crane, boilers, air compressor, truck traffic and deliveries of materials. When installation of the CIPP is taking place, the boilers may run constant through the night.

There is an odor that is emitted in this CIPP process. The odor is from styrene, which is a component of the resin that cures the line. Styrene has a very distinct odor, for example, like the smell of latexes, paint or polyester resins. The city has been using this method of CIPP for many years, so I do not anticipate any problems from the odor.

The residents will be notified of the project by a courtesy notice from the city and we will also require the contractor to send a notice out one week prior to the liner installation. Additional communication from the contractor will be made to the residents where sewer interruptions will occur.





Percent of deaths associated with influenza, RSV, COVID-19, or pneumonia by week, Vital Records








# Influenza-Associated Hospitalizations



### Wisconsin positive influenza results and subtypes by PCR, NREVSS








## Respiratory Virus Activity in the Emergency Department (ED)

Percent of ED visits with a diagnosis for a respiratory virus or acute respiratory infection (ARI), NSSP




Percent of ED visits with a diagnosis for influenza by age group, NSSP


Age Group (years) - 0-4 - 5-17 - 18-64 - 65+



#### Percent of ED visits with a diagnosis for SARS-CoV-2 by age group, NSSP




Percent of ED visits with a diagnosis for RSV by age group, NSSP






## Wisconsin ILI Activity

Three-week average percent of visits for ILI by influenza season, ILINET




Average percent of visits for ILI by public health region, ILINET



#### Surveillance Report Description

Influenza-like Illness (ILI)	Patients who present to a clinician with a fever $>=100$ degrees F and either a cough or sore throat.				
Influenza-like Illness (ILI) Activity	Using baseline (expected value data used for comparision) in each of the public health regions in Wisconsin (https://www.dhs.wisconsin.gov/lh-depts/counties/index.htm), ILI below baseline is considered low activity, ILI between baseline and threshold levels is considered moderate activity and above threshold is considered high activity. (1)				
Acute Respiratory Illness (ARI)	ARI is a broad definition designed to capture all diagnoses related to respiratory illness, including SARS-CoV-2, influenza, pneumonia, and cough				
Predominant virus of the week	These data are compiled from over 40 laboratories in Wisconsin that perform rt-PCR testing, and shows the viruses that have the highest percentage of positive tests.(2)				
Influenza-Associated Pediatric Mortality	Deaths among children $<18$ years old, with influenza as the cause of associated cause of death. This is a state and nationally reportable condition. (3)				
Deaths Due to Pneumonia, SARS-CoV-2, Influenza and RSV	Proportion of deaths due to pneumonia, RSV, influenza, and SARS-CoV-2 are extracted from Vital Records managed by the Office of Health Informatics through ICD-10 codes and death certificate text searches. (4)				
Respiratory Viruses by PCR	A molecular laboratory method used to detect nucleic acid (DNA/RNA) in viruses, including influenza and RSV.				
Influenza-Associated Hospitalizations	Patients hospitalized for >24 hours with a laboratory-identified (by rapid antigen or rt-PCR tests) influenza.(3)				
Emergency Department Data	These data are from the National Syndromic Surveillance Program or NSSP. Visit information from almost all EDs in Wisconsin are reported from hospital electronic medical records to NSSP in near-real-time. Diagnoses used included the CDC Broad Acute Respiratory DD v1, the CDC COVID-Specific DD v1, CDC Influenza DD v1, and the CDC Respiratory Syncytial Virus DD v1.(5)



#### **RE: DECLARATION AND ORDER OF PROHIBITED DANGEROUS ANIMAL**

Please let this letter and the attached order serve as your notice that the City of Appleton's Humane Officer has formally declared your animal, **ARCHIE (AUSTRALIAN CATTLEDOG, MALE, N+, L+ 661 2024, R+ 2025 KAUKAUNA VET)** as a **Prohibited Dangerous Animal**, pursuant to the City of Appleton Municipal Code, Section 3-134.

I have declared your animals, ARCHIE (AUSTRALIAN CATTLEDOG, MALE, N+, L+ 661 2024, R+ 2025 KAUKAUNA VET), as a prohibited dangerous animal after conducting my investigation, which is summarized below:

• On 3/10/2024 Archie was involved in an animal attack vs a human, #A24011172. During this incident it was reported that Archie was sitting on a chair not showing any signs of aggression. A family member went to move Archie off the chair and placed Archie on the ground. Archie then attacked this family member biting the victim multiple times on the face. This attack caused multiple wounds to the victim. One wound on the victim's right cheek was approximately 2 inches in length needing multiple stiches to close the wounds. Another injury was to the victim's nose, needing multiple stiches to close. The most significant wound suffered from the victim was a laceration approximately 4 inches in length above the victims left eye. This wound also needed multiple stiches to close. This animal attack was considered to be an unprovoked animal attack.

Due to Archie causing serious bodily harm on a peron, (REF. #A24011172), I am declaring the animals known as ARCHIE (AUSTRALIAN CATTLEDOG, MALE, N+, L+ 661 2024, R+ 2025 KAUKAUNA VET) as Prohibited Dangerous Animals that should be prohibited within the City of Appleton.

#### **IMMEDIATE ACTION IS REQUIRED:**

Because ARCHIE (AUSTRALIAN CATTLEDOG, MALE, N+, L+ 661 2024, R+ 2025 KAUKAUNA VET) has been declared as Prohibited Dangerous Animals, you must not bring the animals into or keep the animals within the City of Appleton. You must <u>immediately</u> comply with this order, pursuant to City of Appleton Municipal Ordinance 3-134. You may arrange for the animals to be held outside of the City of Appleton, or the animals will be confined subject to Wis. Stat. 173.21. The pertinent section of the municipal code is attached to this document. This order is intended to protect against injurious results to human beings and domestic pets caused by unprovoked attacks by your animals. The location of the Prohibited Dangerous Animal needs to be communicated to the Appleton Police Department per AC 3-132 (I) NOTIFICATION.
