We have no public hearings or appearances this afternoon. So, we'll move on to action items. First is 24-0374 request to approve minor amendment a special use permit number 12-00 for a sidewalk cafe with alcohol sales and service in front of 523 to 525 West College Avenue. Thank you. Chapter nine of the Municipal Code requires a special use permit for sidewalk cafe with alcohol sales for businesses that have a valid food permit and alcohol license. This property currently holds both of those licenses and currently has a special use permit that was granted in 2000 for a restaurant with alcohol sales. Therefore, they're permitted to apply for an amendment to their current special use permit to add the sidewalk cafe to their current special use permit. So that is what the request is about. Staff had reviewed the findings of fact and we're recommending approval of the special use permit amendment along with the resolution attached to the staff report.

No, there's different hours in chapter nine. So, there's a restriction of hours. It's 4pm to 9:30pm is the hours of operation for sidewalk cafes with alcohol sales, and that's when the tables and chairs would need to be removed from the amenity strip.

Okay, thank you. I'm sorry; I missed that.
