I would just like to remind committee, because we're in a new sort of committee shape here that this was referred back by staff with some questions about the establishment. I was hoping OB's would be here to ask some questions. At this point, maybe I could ask staff to weigh on this. Whoever wants to field that. District five. Thank you.

Assistant Chief Todd Freeman (Police) 28:51

Yes, thanks, chair. Chief and I had discussion along with a district commander. Really a situation we found ourselves in before with a business that almost has two sides, a restaurant side and the nightlife side. It's the nightlife side right now that that the police department's very concerned about and working actively to instill some accountability. We see this more related to the restaurant side, and we've had this in other establishments. Typically peer pressure, but because there are expectations there are business peer pressure, there are a separate set of ordinances governing amenities strip use for the request for the picnic tables. And we're simply just not overly concerned about it as it relates to our overall bigger picture concerns. This is not an issue that we'd strenuously object to.

Alderperson Alex Schultz (District 9) 29:46

Okay, can you give us a little insight on how this works with businesses as you just stated that are running an operation during the day and then they have sort of a nightlife where they're serving alcohol. They've got outside areas where those people are coming out to consume. Is that correct?

Assistant Chief Todd Freeman (Police) 30:03

This would be—I'd have to polish up on my amenities trip ordinance, but yes, this would be—there are I do believe requirements on presence of operators, of bartenders, of staff monitoring. I—again, I'd have to brush up on that chapter, but I believe there's discussion about 9:30pm with the amenity strip tables chairs being cleared. So, we'd have to make sure that we're holding the establishment accountable to that.

Alderperson Alex Schultz (District 9) 30:36

So, we have a we have a number of establishments on College Avenue who have this same setup. I can think of half a dozen probably, if I think about it, and they're all under the sense of the same guidelines. Essentially, at a certain point night, they have to clear those tables and they shut them down. Everything moves inside.

Assistant Chief Todd Freeman (Police) 30:52

Yes.

I don't know what the demerit point status is with respect to this establishment at this point. I believe—I don't have a recollection of any other more recent offenses. Not that that's dispositive. I know there have been a number of incidents but not necessarily that are subject to demerit points at this point.
