**Background:** Gold Cross Ambulance Service (GCA) and the City of Appleton entered a shared service and operating agreement on October 1, 2023. During the agreement's formulation, a presentation occurred in front of the City of Appleton's Safety and Licensing Committee. At their request, a bi-annual report will be generated and shared with the committee.

**Reporting Methodology:** The City of Appleton Fire Department has been working collaboratively to gather and share data that is gathered by both entities.
