Thank you. Not too long ago we had a pretty extensive conversation discussion in regards to food trucks and limiting their time in regards to when they could operate downtown Appleton, and the reason for that was we were concerned with people after bar time congregating at these food trucks and problems arising. Obviously, we didn't do anything in regards to eliminate the hours of the food trucks.

I don't know where I'm going to—and recently we approved tables and chairs in the vanity area of one of the establishments in the 500 block of West College Avenue which is a problem area, but that establishment stated at that at nine o'clock they were going to bring in the tables and chairs.

The difference between that place and the taco place is, it says here, it says here—I'm getting the impression tables and chairs, but when I look at the picture, we're looking at picnic tables. And so, we're not—this establishment is not going to be bringing in the picnic tables. They are going to be out there. Which means in my ride along what I saw in the past, a lot of people after bar time is congregating in that area, and they are a problems in that area after bar time. So, if they wanted to take away the picnic tables I wouldn't have any problems with this and just have regular tables and chairs that they could bring in at, let's say nine o'clock, like the other establishment. But leaving these out 24 hours a day—I mean, this is just going to be a problem.

Yes, thank you Chair. I guess my comment would be that their submittal is complete can say that much. And as far as I know, this is a cleanup of an existing condition. So those tables are out there today as is shown in the photograph and that city staff had identified that this was this was currently taking place without the required permit.

#### Alderperson Denise Fenton (District 6) 27:47

Can I ask—so I know that there was—that the existing ordinance allowed them on College Avenue, that that area of State Street is considered to be part of the district and therefore they would be allowable there. Am I understanding that correctly?

#### **Deputy Director Pete Neuberger (Public Works)** 28:08

That is my understanding as well.

#### Alderperson Denise Fenton (District 6) 28:10

So would we have any basis for denying the permit based on—I would understand that we couldn't deny a permit based on the physical location or the history. But is there any basis for denying the special use permit based on the permanence or movability of the—and I'm asking anybody legal or—what microphone?

I think you'll look at the completeness of the permit but also if the committee can articulate other concerns basically based on public health, safety, welfare reasons for having tables in any location that would be a basis to deny. It just would be important for the committee to articulate what those concerns are.

#### Alderperson Denise Fenton (District 6) 29:04

Thank you. I saw Alder Siebers first and then Alder Firkus.

#### Alderperson William Siebers (District 1) 29:09

This established—this establishment can still and will—if we take the tables away, the picnic tables—they're not just individual; they're picnic tables. If we take them away, this establishment still will be open doing business, selling out of their restaurant like they've been doing for quite some time, like a food truck almost. So, it's not going to hurt their business at all. It's just going to prevent people from congregating and, sad to say, make it an opportunity for problems to arise.

Alright, I saw Alder Firkus, next Meltzer, and then Hartzheim.

#### Alderperson Brad Firkus (District 3) 29:58

Thank you, chair. So based on—I think Alder Siebers raises a really good point about the chairs and the permanency. Definitely something I hadn't thought about before he made those comments. Am I understanding

I'm assuming there is no—I mean, I'm sure they would like to have this shored up as soon as possible, but I'm also assuming that we can probably take two weeks into this if just to make sure on that.
