24-1025 our Q2 2024 report. Dr Sepers, quarterly report.

Health Officer Charles Sepers 41:43

Yeah, and I'll just highlight a few data points here. So, looking at the gastroenteric data point, you know, versus—in 2024 versus 20—this point in 2023, we do see a large increase. We don't have an explanation for what that is. We—there isn't a single picnic or a restaurant-based outbreak or anything like that. We're seeing a lot of large independent gastroenteric events. And so, you know, there's the general idea about food safety and good hand hygiene, that kind of thing is a strategy there.

We are also seeing that national trend for an increase STI/STD rate amongst those under the age of 18. That continues to be a very alarming number on par with that national trend. So just highlight that.

Health Officer Charles Sepers 42:53

We did see—so now we're past the that one year mark of when the federal lead elevation levels had dropped from five to 3.5 so we're really comparing apples to apples at this point now. Using the Align methodology, we are seeing a decrease in lead elevations by quite a large amount. So, something to highlight there.

Also want to highlight the creation of our Community Resource Navigator and the hiring of that position. [Cheryl Schaeff?] has come on into the Appleton Health Department, is based at the Appleton police department, funded by the Community Development folks. So that's part of a community development block grant funding on that. So, Cheryl's great. She's got a back—a background of 20 years of being a licensed social worker, so really fun to learn from her as she explores providing those basic need—technical assistance to those experiencing homelessness.

And then the other sort of magic—major data point that I would highlight is we are seeing an increase in the need for public health nurse visits. And so, this is over a variety of different reasons. So, 79 versus 49 this time last year. Part of that is an increase in LTBI. Part of that is more—sorry, that's latent tuberculosis infection. So, the non-transmissible form that still needs treatment. But in in terms of the community referral piece, we are seeing a large increase in that, something that was kind of hampered during covid 19. That's kind of rushing back, so. A lot of different reasons related to that, but, and also that that prenatal care coordination function as well is a big piece of that. Those are the pieces I would highlight. And happy to take questions about anything else.

And then I have another question regarding STDs under the age of 18. What is our plan moving forward? Are we reaching out to our partners in the community to have maybe an educational awareness or a targeted situation where we're reaching out to where the educational component is going on?

Yeah, that's, that's a great question. One of the, one of the things that we're currently doing now is we are contracting that that STD—that STD follow up through a community partner. We're going to propose in the 2025 budget that we take back that that work, and that will give us more control over what that follow up looks like, and devise a, you know, a more robust education component around that.
