The project basics are listed on the cover sheet of the DOT memo. 2027 construction year. So, the cost share estimates that are provided on page three are based on the current cost estimates, and we anticipate receiving updated cost estimates from the from the DOT if the need arises.

I do have one question on that. So obviously, it states that anything over the maximum amount that the DOT is paying—I understand that costs have leveled off a little bit, but how much exposure do you anticipate the city having for any kind of big cost increases?

# Deputy Director Pete Neuberger (Public Works) 04:33

So that is—that is somewhat of a concern for cost estimates that are generated over two years away. I would say there is some exposure, and there are historic examples of two different directions that have happened in the past on that. One direction is the city submits a request for relief from the DOT to see if additional federal funding can become available to cover unforeseen cost increases. The other is those cost increases don't materialize and then the local cost share becomes greater. So, it's very difficult to predict down the road, what might happen to construction cost increases, but, yes, the DPW is aware that there is some potential risk involved in unforeseen cost changes. The DOT cost estimates do try to factor in anticipated construction cost increases, but, you know, we saw some time ago that those increases can be somewhat volatile. So, we're relying on the DOT's system to work to the best of that they're able to figure it.
