Thank you, Chair. I voted against this in the finance committee because I needed more information, and I did get further information from Director Rachman, and I was very appreciative of the discussion that we had. My concern are—my concerns are twofold, one, that this seems like a lot of money to do redo a mission and vision for the city when a mission and vision for the city should be pretty straightforward: treat taxpayers equally, you know, be fair and kind, etc. I know that that's boiling it down quite a bit, but you see where I'm going with that.

The other—pardon me, the other issue that I had was that I feel that this sort of blindsided us a little bit in that it should have perhaps come with the whole discussion about the Comprehensive Plan, as that was very strongly passed, and we are prepared to update the Comprehensive Plan. And this, I feel almost came as a little tail end, "Oh, we should do this as well," and that makes me a little bit concerned. So again, I talked with Director Ratchman about it, and got some good feedback from him about how this kind of came about, but I'm still not convinced. So, I intend to vote no, not because I don't appreciate that this is something that might be helpful for the city as an organization, but just because I feel that it came out of nowhere a little bit.
