So, Alder Croatt with this being your resolution, I'd like to turn this over to you first. Make any remarks that you wish.

Alderperson Chris Croatt (District 14) 01:24

Yeah. Thank you very much. And I know we held this at the last meeting with the hope of maybe having all members present, but that's okay. We'll take it up tonight. Actually, pretty simple. If you read the resolution, there are a few whereas clauses, but mainly this is just asking for a higher than a simple majority vote on an important action item like change to the wheel tax which has the potential to impact citizens of Appleton and much like other budgetary votes that we take that require a higher than simple majority vote. I just feel like there should be a higher threshold for the wheel tax vote because of the direct impact that it can have on citizens and also the impact that it can have on the city of Appleton departmental budgets. All right. I have a couple of questions for Attorney Behrens if we can get you a microphone, please. Just really—just process questions here, just for my understanding and hopefully the committee. Which microphone did you get? Director three or three? Director three, sorry.

All right, so this is looking to change a vote threshold, but to pass this would require just a simple majority from the council. Is that correct?

Okay, and say, some future Council a year from now, 20 years from now, decides they want to change their mind. Would that also be a simple majority vote to revert this or is there a higher threshold if—like, once you've set a high threshold, you need that much threshold to overturn a thing?

Attorney Christopher Behrens 02:58

No, it would it would be simple majority, because it's an amendment, essentially what this is proposing, and it's an amendment to the wheel tax ordinance.

Alderperson Brad Firkus (District 3) 03:07

Okay.

Attorney Christopher Behrens 03:07

That amendment would be to impose a requirement which I understand it to be a two thirds threshold to change the amount of the wheel tax moving forward. But a subsequent amendment to that ordinance would be just require a simple majority as any other amendment to ordinances would require.

Alderperson Brad Firkus (District 3) 03:27

All right. That's all I got. Thank you. Anyone else? Alder Fenton.

Alderperson Denise Fenton (District 6) 03:33

Thank you, Chair. I see no problem with this. We have different thresholds of majorities for budget amendments, and I think we even have a three fourths majority required for things involving salaries and such. So, honestly, I don't see any issue with having this meet the same requirements as we have for other financial issues.

Thank you. Anyone else? Alder Hartzheim.

Thank you, Chair. I would concur. I feel that if this big a change can't meet the thresh—threshold of two thirds of 15 people, then it really shouldn't happen. And that's, that's just the gist of the entire thing. So, I'm all in favor of it. Thank you.
