So, we will be utilizing a drop box for the election. It is set to be set up next week, and it's not going to work as I had hoped and dreamed, but it's still going to be out and available. It will be in the exit to the alleyway by the finance payment windows. So, in the past, we've had it set up in the alley, but with the alley being closed, it won't be accessible by vehicular traffic, so it will have to be pedestrian walk-up for that drop box. So, it will be right in by those finance windows, and that should be set up next week when ballots are going out, so voters can return their ballots in the drop box up until the—up through the Monday prior to the election, November 4.

Otherwise, we go—if they can call us and we can find where they're parked, then we can come out to facilitate curbside voter registration or voting, but we would direct them to those stalls once they are signed. Hopefully we'll get a College Avenue one for this upcoming election as well.
