Thank you, Chair. I'm a bit concerned about this because of the price tag, and I conferred with Director Gazza and Deputy Director Flick in this regard. And I'm, I guess I'm still concerned, but the concerns were alleviated a bit in—if Deputy Director Flick can just rehash what he and I discussed in regards to the portability, etc., of this, I would appreciate that.

# Deputy Director Tom Flick (Parks and Rec) 01:52

Thank you, Chair. Some of the conversations that we've had revolved around, why is the expense so intense? And it comes down to the walls. The furniture is pretty standard. The breakdown roughly about \$13-\$14,000 of that total is for furniture, chairs, and equipment. The remaining funds are for the walls. These walls allow the flexibility not just for PD but for all the departments, if we were to want to reuse this equipment in another setting, another layout, if there was a need. This is moving towards, I'd say, a standardization of office walls. These walls are also insulated to meet HIPAA law requirements for privacy for the staff members that will be utilizing these offices. Heavily constructed, they are your typical steel frame door with the wooden with the wooden door, kind of similar to what's in here, again, for sound barriers, etc. Glass is involved in this, I'd say, design of the of the units.

# **Deputy Director Tom Flick (Parks and Rec)** 02:57

Ultimately, we did look into, can we construct these walls? Our staff probably could construct them cheaper. However, we do not have the time or the labor hours to put towards this. So, if we had to hire an engineer to design the walls, put it out for public bid, most likely it would be more expensive to build these offices than going with a modular unit through a competitive bidding process. So, we are receiving municipal pricing with these modular units, so it guarantees us the lowest price from the vendor.

All right. I have a question though. About how often historically have we repurposed like, where this modularity has been a benefit to say, where we've been able to take what we already have and reconfigured elsewhere. Is that something that we've done kind of regularly?

#### Deputy Director Tom Flick (Parks and Rec) 04:44

No. So we just started this process with the Health Department. We completed the remodel there. A lot of those offices are with these modular wall units that can be reused throughout the city and in other departments. So, PD would be the second option that we're asking to do this. We are asking in the 2025 budget for renovation of the park and rec department, in which we'd be looking to go into the modular units there. So again, starting the process of a standardization and having the same furniture throughout our city complexes.

#### Alderperson Brad Firkus (District 3) 05:18

All right, I just kind of asked, because I sense between when we had the discussion about the Health Department remodel and this one, I've had conversations with someone who, within their daily work does this kind of work, and commented to me, just by chance, that how expensive these were, how much more complex these were

than doing your custom stud and dry wall type construction. So that was something I'm taking into consideration, is comments of somebody who's worked with these types of systems in the past and has made remarks to me, again, kind of more off the cuff, but still.

# Deputy Director Tom Flick (Parks and Rec) 05:51

They are expensive, but the flexibility, I think, is probably what's most important with these with these units.

And on that note, I think it's—not that I'm trying to convince anyone else, because I'm still not 100% convinced, but I think it's important for these particular pieces to be module—modular, because these two particular jobs are to be embedded in the police department, but somewhere along the line, may end up elsewhere in the city. So, I think it would be important for us to be able to say we can basically pick you up and move you to wherever we need to have these positions best stationed.
