Can I ask about—Alder Croatt, or anyone on the on the committee, is there future thinking about where Alder salaries go? Is this—so this is zero now, but are these essentially flat, or is there a sense of that over the years we want to raise this? I would just point out that Alder salaries in 2016 were \$5,921 it looks like, and if you just keep up bare with inflation, put it into one of the calculators online, that comes out \$7,700 so you know that has, in real—the amount of money declined. And do we have, do we have a plan to keep up with inflation in any way?

Just going back to the alderperson salary vote. Note that the vote was 10 to three to one. The recommendation was for a 0% increase. Statutorily, for aldermanic salaries to be improved, for an increase, you need a three quarters vote. So that vote doesn't meet that threshold, but the—in the end, it's the same result. If you don't have a vote that meets the threshold, there is no increase. So, while the vote didn't meet that statutory threshold, the vote total in this case, the end result is the same. I just wanted to point that out, because I know there's been some questions about that raised.
