All right. Good evening. I now call to order this special session for the adoption of the 2025 executive budget and service plan. Today is Wednesday, November 13, 2024. Tonight's invocation will be a moment of silent reflection. Please rise and join me.

All are represented, with the exceptions of Alderpersons Heffernan and Schultz, we hope will be joining us shortly.

All right. I have no business to present to you this evening. Move on now to public participation. Is there anyone who wishes to speak? Anyone who wishes to speak? All right, hearing none. We will close public participation.

Move on now to establishing the order of the day. First item on the list here is item 24-1468, approve the Finance Committee budget workshop minutes. Is there a motion to refer that back? Need a motion to suspend the rules. We have a motion and a second to suspend the rules. This is not debatable. Requires a two thirds vote to pass. Please cast your votes. That motion passes 13 to zero. And at this time, I'm going to welcome up the Finance Committee Chair Alder Firkus to take us through it.

All right. Good evening, everyone. To get this ball rolling, we'll need a motion on item—excuse me—item 24-1468, the minutes from the Budget Saturday workshop. We have our motion and second. All right, so now, with

the motion on the floor, this is the point where we would be voting on any amendment that had been offered. There have not been any offered in advance, correct? So, Alder Hartzheim.

If I remember correctly, there was one amendment that was offered during Budget Saturday.

It was but it was addressed during Budget Saturday. So that is baked in at this point. All right, so I will give one—one chance. Are there any last second amendments? I don't see any offers, so we are going to go ahead and vote. All right, that motion passes 13 to zero.

So now I will need a motion to rise and report. Just bring up my notes here. Yep, rise and report. Looks like we have our motion and second. All right, so we will go ahead and vote on rising and reporting. And that passes 13 to zero. All right, we're out of committee of the whole then.

All right on to 24-1472, the 2025, budget resolution. And before we have a motion on this, I'll ask for a reading of the resolution from our finance director, Director Ohman. All right, go ahead.

Director Jeri Ohman (Finance) 09:56

Thank you. Resolved, the 2025 executive budget and service plan as published in the newspaper and subsequently amended by the Common Council be adopted as amended. There be levied upon the taxable property of the several wards of the city of Appleton the sum of \$39,293,263 for general fund purposes.

Director Jeri Ohman (Finance) 10:18

Be it further resolved there be levied upon the taxable property of the several wards of the city of Appleton the sum up \$13,875,500 for debt service bonds, there be levied upon the taxable property of the several wards of the city of Appleton the sum of \$2,092,000 for special revenue funds, the Department of Finance be authorized to sell General Obligation promissory notes and or bonds in the amount of \$11,301,180 including contracting with bond counsel, financial advisors, and rating agencies as necessary. Further, an official statement may be prepared and distributed by the director of finance in support of the sale. The director of finance be authorized to sell water, sewer or storm water revenue supported bonds in the amount of \$11 million including contracting with bond counsel, financial advisors, and rating agencies as necessary. Further, an official statement be prepared and distributed by the director of finance in support of the sale.

Director Jeri Ohman (Finance) 11:22

Be it further resolved that all projects included herein are not appropriated or authorized to proceed until non-tax funding sources are committed without recourse.

And we do have a motion and a second to approve. Is there any discussion on the budget resolution? Hearing none, please cast your votes. Motion passes 12 to one. Resolution has been approved.

All right, that motion fails unanimously, and with that, we have a budget. Thank you all.
