But other than that, everything else is pretty much status quo.

We actually have been receiving more funding coming in from our collection efforts. So even though we're writing them off our books, we continue to pursue collections. So, we have three different collection—outside collection methods that we can follow. Most of the ones on both of these lists have been sent to collections or were within the process to send them, but it's just a matter of cleaning up the books before year end comes.

Thank you. And then the other question I had was, if some of these are for default organizations, how is that pursued? Is that—it—can it be pursued?

### Director Jeri Ohman (Finance) 06:43

It depends on the organization. So, if there—if it was a sole proprietorship, I believe that can still follow through with collections. So, in some cases we can; in some cases we can't.
