So, this year, 2025, Ballard Road interchange will be closed for reconstruction, and the temporary signal will be in place at Rich—Ridgeview and Richmond. That'll stay throughout the calendar year of 2025, and then in 2026 when Richmond Street interchange is closed for reconstruction, when the traffic is down in that

area, because of that, we're going to go ahead, take the temporary down, and build the new signal while under a four way stop condition at that time.
