Okay, moving on to public hearings or appearances. There is nothing scheduled or listed there. We're going to take our action items in the order that they're on the agenda based on who's present today. So, if we skip one, will take it up at the end. Kelly Arndt is not here, correct? Kelly Arndt? Okay. We're going to skip that and go to 24-1496, which is the operator license for Katherine Neubert. Katherine is present. Okay. We have your application. We have the clerk's issue—clerk's issued letter. We have the denial letter and a follow up document as part of our packet. Anything from staff to start this off? Clerk or Attorney's Office? Maybe Attorney Buruin, you can explain the memo and the options for the committee, please, since these are sometimes—the options are a little bit different sometimes. District five should be on.

So, there was an additional memorandum from myself that was filed which essentially sets out, in pretty exhaustive detail, the situation, but what it boils down to is this is one of those rehabilitation situations. So, by default, the applicant's criminal record leaves her ineligible for licensure, but based on the nature of the offense and the reason for exclusion, she does have the opportunity to provide the committee and Council with evidence of rehabilitation. And again, the specifics of how that works are set forth within the memorandum. I think everybody's fairly familiar with them. There are some that the committee and council would be required to accept. There are some that the committee and Council are required to consider but not necessarily that would be dispositive. So, this would be an opportunity for Miss Neubert to provide any evidence of rehabilitation that she may have to present, and if she's unable to do so, the committee could either give her more time to do that, or failing that, I believe that the committee would be obligated to recommend denial of the application.

So, I don't have any physical evidence, but I think it's on record in the courts that I went through several AODA assessments as a result from my third conviction. I was also on probation and followed all of the steps and guidelines that she, my probation officer, requested. And I also do currently have a operator's license in the—in

I'm not sure if you want to learn more about that or not?

I apologize for that. This is the first I'm hearing of it, so I'll follow up with staff to see what happened.

We have the application, we have the clerk's letter, we have the Appleton police department response letter, we have the appeal memo, and then we have an updated document. I will start with the attorney's office on this one, because it may be a little bit different, one of those different scenarios, correct?

Correct. It's different from when we were here originally. The memorandum that I filed—I believe I filed....

Yeah, the last document is the one with the most current recommendation or information that the committee needs to get.

So, my December 13 recommend—or memo essentially sets it out. We're in a very similar situation, at least for the time being the last individual. There is a conviction which would leave us in a situation of there being a disqualifying criminal record or criminal and/or arrest record. There is the opportunity for demonstration of rehabilitation, as set forth in the memorandum, again, very similar to that. This is all subject to change as the other matter, or if and as the other matter comes to its conclusion, depending on what the conclusion of that is. But with the information at this point, available, at this point, this is going to come down to whether or not rehabilitation can be demonstrated in the manner set forth by the statute.

Hi. Kelly Arndt, [XXXXX]. I'm already in treatment. Voluntarily, I put myself in treatment for almost, I would say, six months now, and I have documents and letters. If you guys would like to hold this until the next meeting, I can provide all those documents and letters from my treatment counselor and from my lawyer and everyone else. I didn't currently have those because I was under the impression that you guys were granting this in my motion. So, I didn't have those letters prepared with me. If you guys are willing to wait, I will have them here at the next meeting.

Okay. For the reasons of allowing the applicant to deliver information relative to rehabilitation. Okay. Just want to be clear on our reasoning for holding. Is there a second?

Okay, we have a second by Alder Schultz. Comments? Questions? Alder Doran.

Just a question for the attorney then. Based on the information provided, the—we still have the option to approve the license based on the applicant's ability to provide rehabilitation, correct? Even though the conviction states that would make her ineligible?

Zak Buruin (Assistant City Attorney) 11:19

Yes, the convictions—many convictions, are going to leave somebody ineligible. Some of them—and this is one of the situations—the conviction that is in place in this case, that ineligibility is subject to the ability to show rehabilitation. So, at this point, not having provided any documentation regarding rehabilitation, she is ineligible. If she provides that, depending on what type of evidence it is, if it's of the type that the statutes say the committee and the Council have to accept, then she would have to be granted the license. If it's within the realm of the things that the committee is required to consider but not necessarily accept, then there would be a discretionary ability to grant or not.

We're not in a position to consider that at this point. There's not enough information to consider the facts of it. The conviction itself could become an issue later on, if there is one. That all assumes how that goes, but that's something that we'll have to keep track of and deal with when and if it becomes an issue. But for the time being, it's not.
