We have a motion to approve and a second. Director Gazza, this is the event that happens at Memorial Park, is that correct?

Director Dean Gazza (Parks, Recreation, and Facilities) 02:23

Yes, it is. We put out a request for proposal, and we received two responses for that. We received other interests, but some of the groups realized the magnitude of the event would be too challenging for them. So, two groups that have significant experience in putting on large events like this. We evaluated it. We included the attorney's office, police, fire and parks and recreation, and we unanimously selected Wisconsin Entertainment Group based on the factors that we were looking at, which just overall this experience, the proposal, what they were looking at providing for the event and trying to mirror what was provided in the past, references, financial ability, safety record, things like that. So, yeah, we're excited. We're really excited. The group with Wisconsin Entertainment Group is very eager, and they have a lot of, I guess, success getting donations. So, they're looking at going after donations. They already got some commitments. Have, if this goes through, which will help them, you know, make sure that the event is a great event.

Is this a change of vendor for this, or who has done it in past years?

Director Dean Gazza (Parks, Recreation, and Facilities) 03:54

Yeah, the Jaycees had did it in the past, and they basically couldn't handle the event anymore, just for a lack of membership with an organization. So last year when they notified us, there wasn't enough time to find another organization. So, then we as a city, put it on, but we only did it as a fireworks only. We didn't have all the activities during the day which included the music, the children's events, and things like that. So that's the intent, to bring it back and have a group like that do it.

They have—they can get, you know, the workforce to handle the event. So, it's something we wouldn't be able to do on our own. That's why we limited the event to the to what it was last year.
