So as indicated there, we went out for an RFP in 2022 and selected NES on a quality-based selection process with the first year 2022 being contracted, and then the RFP process also stated that we would look to negotiate single source contracts with NES for the remaining of the of the four years.

So, we're just about through that five-year period, and NES has been doing fantastic work for us. They're a local contractor. A contractor that had been doing work for us for quite a few years before that, they were located in the southern part of the state, and you may recall that they stopped servicing this area. So that was a—that happened relatively quickly, but we were very happy to have NES on board, and their track record has proved that we made a good decision in hiring them.

Deputy Director Pete Neuberger (Public Works) 03:51

So, if Director Jungwirth has any contributions to make, I happily, happily pass that over to her. But I would say I don't think that there's a whole lot that we can derive from, like the reverse trend or anything like that. You know that we continue to try to address aging—our aging infrastructure. As we reconstruct streets, we go after those and undersized mains. There is a little bit of luck involved each year. The weather, of course, has something to say about it too. Very cold conditions can have an impact on frost in the ground and things like that. Those are all factors that that weigh into that. So, I would say, I don't, I don't think that DPW thinks that this is a result of any deficiency or anything like that in terms of our approach to maintaining the system.

Alderperson Vered Meltzer (District 2) 04:44

Thank you. Yeah, just looking here the, as far as, like the year for the age of the pipes, most of them are from the 60s, a couple of them from the 40s, and the youngest one was from 1978. So, I think that that—that doesn't show anything concerning to me, as far as the types of breaks that we're having.

Director Laura Jungwirth (Public Works) 05:04

And to add to that, in the 60s/70s, there was a stretch of problematic pipe material. So, if we do see a trend in that kind of time frame, some of that could be attributed there. And then again, weather dependent. As we start seeing temperatures warm back up as we have, there are some fluctuations in the ground that might cause some breaks, but I think we were at 9 so far this month was January, and we had 7 last year in January. So, while we're a little bit behind, if you will call it that, it's not far off. We're not seeing anything excessive.
