I'm the executive director of Appleton Downtown Incorporated and Creative Downtown Appleton Inc, and here to speak on the locator pin photo op proposal that we submitted six weeks ago. Yesterday we received our quote on materials, specifically on the aluminum sheets that it will take to fabricate this piece, and much to our surprise, it is actually priced us out of fabricating the piece as it has been presented. Additionally, the groundswell of negative feedback following an alderperson's post on social media has given us pause. So tonight, I'm asking to have this item referred back, so we have an opportunity to retool our design and take this up at a later date. Thank you.

Thank you, Chair. There was a request from the Arts Committee to have this brought back to them as well. So, if we aren't sending it to three separate committees, I think I would object to just sending it to one, because the Arts Committee did want to speak on this again.

I was—I had—I was—the chair of the Public Arts Committee spoke to me, and there was perhaps concern from an additional member of the Public Arts Committee as well that more discussion ought to be had on this item. So given the input that I received from that committee which meets very rarely and perhaps would like more time to engage in their duties as a committee, I feel that this would be a very appropriate time to refer it back to the Public Arts Committee given the nature of the discussion.

Yeah, just to echo that, I also heard from the chair of the Arts Commission, and I think that the concern there was based on the timing and the sensitive timing nature of the request, there wasn't enough time to digest it. So that's really why they want to have it back in front of them. So, I think it makes total sense to get it back in front of the Arts Commission.

And so much of the public feedback has related to the esthetic quality and whether we want this in Houdini. So, I think that the Public Arts Committee is the appropriate place to get another look on what has been the public's main concern as reflected in social media posts. Thank you.
