I mean, if you have a question right out the gate, I'm willing to entertain, otherwise, I'm gonna turn it over to you, if you don't mind, just to give us, just to kind of—I mean, I don't know if anyone has any real questions, but you can just give us a real high level of what this request is for. Three? Oops.

Okay, so this request is to extend a current contract that we have with Truity. About mid-February, we reached out to them. We currently have a temp in our office. She's assisting getting ready for audit. She was hired before we lost our Account Clerk Supervisor on the first floor. So, in addition to helping with audit preparation, she has also been helping take some of those journal entries that was normally done by downstairs and was—she's kind of staying on top of those a little bit more for us. So, this contract would just be extending an existing one that we have with her to 40,000. It would probably take us out until about the end of May. She's doing a great job for us. She knows our current software, so it was kind of a nice, easy pitch to bring her in. She required very little training.

I, like Alder Hartzheim, sometimes am, not skeptical, but reluctant on sole source contracts, but I think in this case, it's very merited, and I think we should support it, just because of the continuity of service that would be going on in this very important department.

It's Monday, and sometimes the numbers get a little. Alright. So, this is a request for site improvements at a open lot just east of that existing municipal services property. So, Director Jungwirth, if you just kind of want to give us a little bit of detail, kind of color in a little bit here for us.

#### Director Laura Jungwirth (Public Works) 04:45

Yes, our bid prices came in very favorably based on what we had estimated. And the work would be for removing some foundations that exist there, getting the site cleaned up, and installing a storm water treatment facility. So, the site will be cleaned up and be able to be used as we need it.

Thank you, Chair. Director Jungwirth is the 161 total for this (with the contingency obviously), so far under budget that—is there anything else within that budget amount, that \$200,000 that's shown, is there anything as far as design, or anything else that we're missing? Or are we that far under budget?

## Director Laura Jungwirth (Public Works) 05:31

We had gotten a pretty high estimate from our consultant that put the plans together and that that purely is the difference. There's nothing that we should be missing.

#### Director Laura Jungwirth (Public Works) 05:43

When we assembled the bid package, we thought it, the estimate, was a bit high ourselves, so we went ahead. We assessed the items to see if there were certain things we thought were going to come back lower, and that did ultimately end up being the case. So, our estimate was actually a bit—we dropped it a bit from what the consultant even had provided us. So.

## Alderperson Sheri Hartzheim (District 13) 06:03

Thank you. I get concerned about this just knowing that we were dealing with some special considerations from the previous year, meaning we had some borrowed funds that were sitting there because we had over budgeted for a project, and I hate to see that much money sitting there as something that we're not going to have a really good thorough discussion of outside of budget time. So that's why I asked that question. Thank you.

Thank you, Chair. Happy to see that three of the four bids were under budget. I think it goes to show that it's a competitive landscape there, because I think a couple years ago, we were talking about either limited bidding or very high bidding where we had to reject bids because it was so expensive to do this type of work. Probably of note, the one, the one that's being recommended, is close by—right? Close by to the facility, so maybe that played into a lower bid.
