So, Milbach Construction, we had—have completed several projects with them. They had renovated—the most latest. They renovated Department of Public Works. Then they renovated the fifth and sixth floor. We did have some issues on the last project that ran into some issues where we looked at ways of possibly executing the performance bond. Them issues, basically, to summarize—I'm trying to take a long story and make it short, summarize where with two subcontractors in particular. So, we did not disbar them from future projects. We had several issues with the timeline. We got the project done. The project was done to our liking at the cos—and at no additional cost for schedule and things like that. So.

But anyway, so when they got the low bid this time, first thing I did, took the extra care and precaution by having the architect and engineer meet with them, go through line by line to make sure that their bid did not miss anything because they were much lower than the last—than the other bidders. And then we brought them into our office. We explained the troubles that we had on the last project, that we would not, lack of better terms, except that same—them same issues—that before they start the project and sign the contract, they are to assure that all their subcontractors will be able to perform per the timeline, per the schedule, per the scope, per the quality, and we went through a meeting with three other company representatives. They assured us that they want to make it right. They want to learn to relationship with us, and they want to show us that they will get this project right and we will not incur the same problems as last time.

So, we felt good after the conversation that though we had issues last time, that we should not see the same issues we had this time. And I think they know this is their last opportunity to work with the city. If they don't—the project doesn't turn out this time and meet all of our goals and objectives, they won't be working with the city again.

Came in higher than budgeted, so we actually pulled back on the red ramp, and are anticipating putting that in our budget for next year. So, to stay under that \$200,000, we did remove red ramp; we will still do the yellow and green roof replacements.

Um, just mechanics-wise, assuming that the everything is status quo and nothing goes over, what would happen to the funding, the reserve fund or the—reserve fund? What would happen to the funds if it was not needed for those projects?

The accrued interest at the end of the expenditure period, once all the projects are completed, our plan, according to this, would be to disperse it in the same way that we do excess fund balance with the general fund. So, we would come forward with that plan, as well as the 75% debt reduction, 25% allocated to different projects according to approval.

So, we would hold the funds until the end of the project period, and then it would be subject to normal carry over rules.

Thank you. And, B, do we really anticipate there is—there will be overruns on any ARPA-related projects? I mean, that's really disconcerting to me.

Director Jeri Ohman (Finance) 1:21:44

So, the first part of the question, we have these funds deposited within the LGIP Fund, which is the Wisconsin local government investment pool, and the rates have been extremely well, starting in I think it was late '21 or '22 when interest rates went back up. So having over 14 million on deposit and not spending a lot of that right away, that's what's accumulated.

For the second part of the question, do we anticipate? Not necessarily, but with costs going up, it is a possibility, and it would give us the ability to come forward to committee and Council for approval. If we found that a project was short on funds, we would come forward with that.

Right. We do have some, like, internal city projects, and I apologize I can't go through the details on each one. I don't have that in the memory bank, but this this would be there.
