




Environmental Public Health

Strength in Standards: The East Central Weights & Measures Consortium

The East Central Weights & Measures Consortium, formed in 2003, is a collaborative partnership led by the City of Appleton Weights & Measures division. Its mission is to ensure equity in commerce by verifying the accuracy of commercial weighing and measuring devices across member communities. By joining forces, the consortium has strengthened regional cooperation, creating a shared framework for enforcement, education, and efficiency. What began as a small alliance has grown to include twelve communities: Appleton, Ashwaubenon, Berlin, Fox Crossing, Greenville, Kaukauna, Kimberly, Little Chute, Neenah, New London, Ripon, and Waupaca, working together to support fair trade practices and consumer protection. This partnership allows for consistent enforcement of standards, better use of limited resources, and enhanced technical expertise across municipal borders.

The strength of the consortium lies in its ability to foster trust, both among local governments and with the public. Communities benefit from streamlined inspections, shared training opportunities, and a unified voice in the state-level regulatory landscape. The result is a more cohesive, responsive, and professional program that reflects the collaborative spirit of Wisconsin's public service.

It reduces administrative costs while maintaining high professional standards. Inspectors are specially trained and bring their own equipment—no added costs to the local taxpayer.

Every inspection sticker you see in a store or gas station is a small sign that your municipality is looking out for you. Thanks to the consortium model, residents get the benefit of expert service, trustworthy transactions, and fair pricing right in their own neighborhoods.



Meet Amy

If you've seen someone wheeling a cart of certified weights into a grocery store or testing a gas pump with scientific precision, you might have met Amy Hoechst. She's been a Weights & Measures Specialist with the City of Appleton for six months, making sure you get exactly what you pay for—whether it's a gallon of gas or a pound of produce.

Amy's background in quality control and life as a stay-at-home mom sharpened her eye for detail. Every day brings something different: indoor inspections, outdoor testing, driving between communities, and lots of friendly questions from curious customers. She often focuses on store-brand items and uses a randomized system to check dozens of products per visit for pricing accuracy.

When the workday wraps up, Amy heads to the community pool with her husband Joe and their kids, Ada and Evan. She loves knowing her job helps build trust between shoppers and stores.
