We're still working through the details of what this would look like, and we understand it could alter our charge back agreement. Just a few bullet points, the beer garden would be clearly marked area.

We have identified Morrison Street north of College Avenue between Johnston and College as the area where they would like to set up. And it is the intense that McFleshman's would hold the license and then hold the liquor liability as well. And lastly, we just ask that you don't hold the Farm Market license as a whole, as we are ready to kick off in just a few short days. Thank you.
