On 11/8/24 at approximately 2330 hours I was on foot patrol working College Avenue security. The bouncer for Brau Haus, [REDACTED], flagged me down to inform me a 20-year-old female just attempted to enter Brau Haus but he denied her entry after he saw her age on her license. [REDACTED] pointed the female out to me, who was walking east on the sidewalk in the 500 block of W. College Ave. I followed the female from a short distance away to see if she was going to try and enter any other bars. The female attempted to enter Speakeasy but the bouncer turned her away. The female then walked to Mr. Frog's, located at 409 W. College Ave., and walked right in. I could see from outside Mr. Frog's window that the female was in the middle of the dance floor and went deeper into the bar. I entered Mr. Frog's and approached the female, who was now at the back of the dance floor near the edge of the bar area and asked her for identification. The female, who was eventually identified by her Wisconsin license as Iyana Ransby, couldn't produce her ID. I asked Iyana to step outside with me. Iyana was confirmed to be 20 years old by her license.

Iyana claimed she showed her ID when she entered Mr. Frog's, yet she never was able to produce it. Iyana appeared under the influence of an unknown substance due to her eyelids being droopy and her words being slurred. Iyana submitted to a PBT which registered .000% BrAC. I later sent Iyana a citation via certified mail for Underage Person on License Premise.

Bryan Mendoza (aka Morales) was in front of Mr. Frog's and said he would try and pull up surveillance footage to see how Iyana entered the bar. Bryan gave me the impression he was working for Mr. Frog's by making this statement. Bryan never produced any video footage for me to review. As I began speaking with Bryan along with fellow Mr. Frog's employee Steven Wells, Bryan told me he was not on duty tonight for Mr. Frog's. Neither Bryan nor Steven gave a response as to how Iyana entered the bar without a bouncer stopping her.

On 11/11/24 I spoke with the owner of Mr. Frog's/license premise holder, Vanessa Alvarado, on the phone to discuss this incident. Vanessa stated her employees told her that Iyana was able to gain entry while the bouncers were engaged in shift change. Vanessa said "Jaron" was one of the bouncers working on Friday night but didn't know his last name (she thought it was possibly Wells but wasn't sure). I told Vanessa I was going to mail her a citation for Underage Person on License Premise and she understood.

APD Crime Analyst Sue Gallagher was able to save video footage from a City camera that is aimed south toward D2/Mr. Frog's/Sal's Pizza. The footage shows Iyana entering the bar then exiting a few minutes later after I located her. This video footage was logged as evidence.

ARREST/CUSTODY: Iyana M. Ransby, DOB: 05/12/04, and Vanessa M. Alvarado, DOB: 03/14/90, were mailed ordinance citations for Underage Person on License Premise.
