INVESTIGATION:

On 11/10/24 at approximately 0208 hours, I, Officer Christopherson, was working uniformed patrol in the City of Appleton, Outagamie County, Wisconsin. I was on foot patrol in the 400 block of W College Ave watching the bar crowd during bar closing time.

I noticed a verbal disturbance between two groups of people outside of Mr. Frogs (409 W College Ave). Officers were splitting up the argument as a female, later identified with Wisconsin Identification card as Mia Averill, had come running eastbound down the sidewalk. As Mia was running, she struck an unidentified male in the back of the head with her right hand. She then continued to walk away from the scene. I stopped Mia and detained her by placing handcuffs behind her back with Officer Derge. We checked them for proper fit and safety locked them. We then brought Mia to Officer Berens squad where I searched her person and advised her she was being charged with Disorderly Conduct. While searching Mia, I located a plastic bag branded "Drench" that stated it contained cannabis. I later logged that package into evidence and queued it for destruction. Due to the large crowd gathering in the area, Officer Berens and I transported Mia to the Appleton Police Department.

Once we arrived at the police department, I obtained Mia's ID out of her purse. As I was doing so Mia stated "That motherfucker, If I did do something, he needed to get hit 'casue he be fucking everybody's bitch" I then completed a citation for Disorderly Conduct (AC 10-9). I explained the citation to Mia and she had no further questions or concerns. Handcuffs were then removed from Mia and she was released from the police department.

It should be noted the male Mia struck had left the scene prior to being identified.
