On 04/05/2025 at 11:50 PM while on duty for the City of Appleton Police Department I, Ofc. Van Dinter was dispatched to a disturbance at Mr. Frogs, 409 W. College Ave. in the City of Appleton. Dispatch advised Holly L. Lukaszewicz, F/W DOB:04/20/1974, called and stated she was struck in the tavern by an African American female in a red sweatshirt and jeans with her hair in a ponytail. This female was later identified as Taja D. Love, F/B DOB:01/30/2001.

Upon arrival I spoke with Holly. Holly stated she went into the restroom. Holly stated once she was in the restroom someone started banging on the door. Holly stated when she exited the restroom she asked Taja if she had to throw up or if something was wrong with her. Holly told me Taja told her to, "get the fuck out of the bathroom". Holly told me Taja started pushing her and then hit her in the face with an open hand. Holly told me when hit it caused her pain without her consent. Holly told me the bouncer also grabbed her and pushed her out of the business.

I spoke with Bouncer Steven Wells M/B DOB:08/21/1996, who was working at the time. Steven stated Holly exited the bathroom and yelled at Taja, "stop fucken knocking on the door". Steven stated he intervened and told both Holly and Taja to calm down. Steven stated Holly continued to yell at Taja and he told Holly she would need to leave. Steven stated Holly got aggressive towards him and he told her she needed to leave. Steven stated he escorted Holly out of the business. Steven located Taja in the business and I spoke with her outside.

Taja told me she knocked on the bathroom door once and then again as she did not know if someone was in there or not. Taja stated Holly exit the bathroom and asked her if she needed to

throw up. Taja stated Holly started getting in her face so she pushed her away from her. Taja stated Holly kept getting into her face and she pushed her out of her face again. Taja stated Steven got in between them and Holly kept coming at her. Taja stated she slapped Holly in the face. Taja stated she wanted to apologize to Holly. Taja stated security then escorted Holly out of the tavern.

I spoke with [REDACTED], F/W DOB: [REDACTED], who told me she was a witness to what happened. [REDACTED] stated she also knocked on the door to the bathroom. [REDACTED] stated when Holly came out she yelled, "Yall cant be knocking on the fucking door." [REDACTED] stated she tried to separate Taja and Holly however Holly got in Taja's face.

I issued Taja and Holly a citation for disorderly conduct. I issued Taja her copy on scene and mailed Holly her copy.

On 04/11/2025 Ofc. Burke attempted to obtain camera footage from Mr. Frogs, however was unable to.
