OFFICER CHRISTOPHERSON REPORTS:

On 05/10/25 at approximately 0127 hours, I, Officer Christopherson, was working uniformed patrol in the City of Appleton, Outagamie County, Wisconsin. I was patrolling the bar crowd in the 400blk of W College Ave when I observed staff at Mr. Frogs (409 W College Ave) forcefully removing someone from the bar. Officer made contact with the male who was being removed (later identified with a Wisconsin Driver's License as Preston Nelson) and detained him in handcuffs.

I entered the bar and made contact with Jaron Cashaw who was staff. Jaron explained that Preston had to use the restroom near the rear of the bar, but somebody was inside. He began knocking and requesting to enter, but was not able to as it was locked and being used. Eventually Preston forced entry into the restroom, damaging the door. At that point bar staff escorted him out of the bar where officers detained him. Jaron estimated the damages on the door to cost approximately \$500.00 and did not give anyone permission to damage it. I took photographs of the damage and uploaded them to evidence.com under this case number.

I then made contact with Officer Hruby who advised Bryan Mendoza (visually identified based on past contacts) had video footage of the incident. I sent him an Axon Community link and he was able to upload the video. I later reviewed the video which showed a male, who I was able to identify as Preston, knocking and hitting the door with his shoulder until he eventually lowered his shoulder into the door, forcing it open.

Officer Hruby issued Mr. Frogs an Outagamie County Victim Rights packet and they opted out of additional services.

Based on Preston's violent and disorderly behavior and the damage he caused to the door, I decided to issued him citations for Disorderly Conduct (AC 10-9) and Destruction of Property (AC 10-23). I made contact with Preston and issued and explained the citations to him. He had no further questions or concern's. He was then released.

VICTIM RIGHTS:

Issued - opted out

ARRESTS/CUSTODY INFORMATION:

Preston R Nelson DOB: 07/15/2000 was issued citations for for Disorderly Conduct (AC 10-9) and Destruction of Property (AC 10-23). Preston acted in a violent and disorderly manner as he forcefully broke through a locked bathroom door. Preston caused damages to the door.
