### Original Narrative

**05/21/2025 20:18:44**

On 5/18/2025 at approximately 0207 hrs. I, Officer Biffert #9139 was inside Mr. Frogs in reference to A25023583. At that time, I noticed a bouncer with Mr. Frogs later identified as Ronni Leavitt inside yelling at some individuals at the front door. It should be noted that the bar was closed and the door was locked. The individuals outside appeared to be asking for a lost phone. I then heard Ronni go up to the door and yell at the group of people saying "who the fuck you talking to". Ronni said this multiple times. Ronni then said "meet me in back", "meet me in the back alley", "meet me in the alley", "you better have a switch on you" "goofy ass nigga" "cornball".

Ronni was then separated and said that I did not know what the other guy was saying. I explained to Ronni that it was not appropriate and obtained updated information for follow up.

It should be noted that after leaving Mr. Frogs, I noticed Ronni start walking south on Walnut St. from College Av. towards the back alley behind Mr. Frogs. I then lost sight of him and observed the other male waiting in a vehicle in the St. Joseph Parish parking lot. That vehicle left shortly after I drove through the lot.

I attempted to follow up with Ronni in reference to this however have not been able to get ahold of him.

Based on my training and experience, Ronni was trying to incite a fight with another individual. I also know the term switch as an attachment to a weapon that turns the weapon into an automatic. Based on these statements and the fact that Ronni was observed walking back towards the area where he told the other guy to meet him, I am issuing Ronni a disorderly conduct citation. The citation was mailed to the current address Ronni provided me.
