On 06/14/2025, at 19:45, I, Ofc. Reader #9171 was conducting alcohol compliance checks within the City of Appleton and was assigned CSO Tyler Piton (M/W [REDACTED]) as an underage individual to work with me. Prior to beginning the compliance checks, I took a photograph of CSO Piton to document his appearance during the checks. The photograph was later uploaded to Axon Capture. CSO Piton went into Mr. Frogs, located at 409 W College Ave. CSO Piton spoke with the bartender, later identified verbally as Nayeli Tierrablanca (F/U DOB: 08/19/2003) who failed to identify him or ask for an ID. Nayeli sold CSO Piton a bottle of Pabst Blue Ribbon for \$5.10. The sale was completed through an exchange of cash. CSO Piton returned to me outside of the bar and informed me of the sale. CSO Piton stated the bartender was wearing a neon yellow dress. I entered the premise and immediately noticed that Nayeli was wearing the neon yellow dress. I spoke with Nayeli, who indicated she sold the beverage to CSO Piton without checking his identification. I issued Nayeli a summons and Officer Berens answered her questions regarding it. The alcoholic beverage purchased was still on the bar top when officers entered. It was photographed and uploaded into Axon Capture. Lt. Goodin was notified of the incident.
